## Health & Safety Annual Monitoring Reports

Action: HOSs please note that:

- (1) Health & Safety Committee has recently approved a simpler annual report template to be used in alternate years, so that managers can affirm that little has changed since the previous year's more detailed report. An amended programme is attached.
- (2) New guidance has been developed on completing the templates, sharing examples of good practice from across the campus.

The University's programme of annual monitoring reports has been in place since the merger and has been a useful tool to report on basic health and safety management arrangements.

With nearly 8 years experience of these, the Occupational Health, Safety & Training Advisory Group (OHSTAG) recommended that efforts should be made to simplify the return on alternate years to avoid unnecessary repetition of detail, and to refocus the reports towards significant changes or developments. A new and simpler template has been approved, and will be sent to you by your University Safety Co-ordinator in accordance with a revised programme (attached, for your information).

OHSTAG also noted that whilst most sections of the templates were generally completed well, two sections were not. These were health & safety goals, and the risk profile tables. New guidance has been developed to assist staff completing these sections, at <a href="http://documents.manchester.ac.uk/display.aspx?DocID=13627">http://documents.manchester.ac.uk/display.aspx?DocID=13627</a>. The guidance quotes examples submitted by colleagues from across the campus that might be useful to others, or might prompt new ideas.
