<u>Ultra-Low Emission Vehicle Scheme Declaration</u>

The Ultra-Low Emission Vehicle (ULEV) scheme is available to staff who meet the necessary criteria. Please make sure you have read and fully understood this document and others referred to before signing.

Please note: If you fail to comply with the rules of the scheme; are found to have deliberately provided false information; or have failed to update the Car Parks Office of a change in circumstances, it may result in one or more of the following:

- Permanent withdrawal/cancellation of any discount and ineligibility to apply for any future discount schemes.
- Cancellation of parking permit with re-entry to the bottom of the waiting list.
- Disciplinary action.

The ULEV scheme is available to staff at the University of Manchester who meet the following criteria:

- 1. The vehicles V5C/logbook (or lease information if vehicle is not owned) confirms that the vehicle emits 50g CO₂/km or less.
- 2. The vehicle registered for the scheme must be the vehicle used to access University car parks.
- 3. The vehicle may be registered to another name (e.g. spouse or parent) but must be registered to YOUR residential address. We are entitled to ask for proof of address as required e.g. utility bill or driving licence.
- 4. The scheme is renewed each October. You must agree to update your records with evidence each September otherwise the discount will cease.
- 5. You are aware the Car Park Services may at any point carry out random checks to make sure you are adhering to the terms of this scheme.
- 6. As stated above, failure to comply may result in one or more of the following:
 - Permanent withdrawal/cancellation of any discount and ineligibility to apply for any future discount schemes.
 - Cancellation of parking permit with re-entry to the bottom of the waiting list.
 - Disciplinary action.
- 7. In the event of sanctions being applied as a result of failing to comply with the rules of the scheme, the Operations Manager's decision is final.
