UNIVERSITY RESEARCH STRATEGY GROUP AND UNIVERSITY RESEARCH GROUP (RSG and URG)

Since the last report the following meetings have taken place: URG (23 March) and RSG (13 April). Membership, standard agenda and ongoing items can be found here.

Important points to note that are not covered elsewhere in this report (or the reports of the ADs for PGR and Social Responsibility):

New/updated items to report from RSG/URG:

Research Income

HESA data on research income for 2013/14 is now available. It shows the University of Manchester research income is up 7.1% on the previous year, slightly ahead of the Russell Group average. The University market share is also slightly up to 4.2% and it ranks first in the UK Industry, Commerce and Public Corporations stream of funding.

Research Integrity and Good Governance

A consultation is underway on how we manage access to sensitive information on the internet required for research purposes (e.g. military information, political radical groups, potentially illegal activities). It is intended that a register of those people requiring access to such information will be established.

University Research Quality Strategy – Research Statement of Expectations This will be launched shortly.

University Open Access Policy

This statement is due to be presented to Senate for approval. It will ensure that we are compliant with HEFCE and funder requirements, supported by use of the University's eScholar repository for green OA deposits.

Leverhulme Major Research Centre call

The University is allowed to submit one application to this call. The one selected to proceed from the original nine expressions of interest were received from across the University includes colleagues from SEED and SALC in a proposal led from CHTSM in FLS.

Business Engagement Update

University and Faculty Strategic Partner Review

A review of University strategic partnerships is underway. The University Business Engagement Group are working to identify priority sectors and companies aligned with the University research beacons, devising a pipeline for progressing relationships with partners and identifying key contacts for each partnership. A short paper will be submitted to the University SLT for comment and approval in due course. Discussion to identify Faculties' priority partners and plans for engagement are underway.

ESRC Festival of Social Science (7-14 November 2015)

In November 2015, the University of Manchester will partner with the Economic and Social Research Council and Manchester Metropolitan University on a Manchester-based Festival of Social Science for the first time.

The Festival aims to provide an insight into the many ways in which social science research has contributed to social, economic and political life across the City, region and beyond. Academics will work alongside community and cultural partners to create engaging and inspiring research-led events.

The call for applications to host events is now open. Any researcher can apply to hold their event under the Festival banner. In addition, academics can apply for up to £1,500 sponsorship from the University of Manchester to hold an event as part of the Festival. Events should attempt to engage with a non-academic audience including young people, third sector organisations, the public, business or local government and policy makers.

MSCA Individual Fellowships in brief

The goal of the MSCA Individual Fellowships is to enhance the creative and innovative potential of experienced researchers who wish to diversify their individual competence in terms of skill acquisition at multi- or interdisciplinary level through advanced training, international and intersectoral mobility.

Individual Fellowships provide opportunities to acquire and transfer new knowledge and to work on research in a European context (EU Member States and Associated Countries) or outside Europe. The scheme particularly supports the return and reintegration of researchers from outside Europe who have previously worked here, it also develops or helps to restart the careers of individual researchers that show great potential, considering their experience. Support is available for individual, trans-national fellowships awarded to the best or most promising researchers for employment in EU Member States or Associated Countries.

The application is made jointly by the researcher and host organisation in the academic or non-academic sectors.

A Career Development Plan should be established jointly by the supervisor(s) and the researcher. In addition to research objectives, this plan comprises the researcher's training and career needs, including training on transferable skills, planning for publications and participation in conferences.

Fellowships are either European Fellowships or Global Fellowships.

European Fellowships:

- Held in EU Member States or Associated Countries and are open to researchers currently within and outside Europe.
- The country where the European Fellowship is held is subject to the rules of mobility.

Global Fellowships:

- Based on a secondment to a third country with a mandatory 12 month return period to a European host.
- The country where the Global Fellowship secondment takes place is subject to the rules of mobility, whereas the return phase is not.

Secondment Phase

 Researchers receiving an Individual Fellowship may opt to include a secondment phase in Europe, notably in the non-academic sector, within the overall duration of their fellowship.

- For a fellowship of 18 months or less, the secondment phase may last up to three months.
- For a fellowship of more than 18 months, the secondment phase may last up to six months.
- The secondment phase can be a single period or be divided into shorter mobility periods - the secondment should significantly add to the impact of the fellowship.

Expected impact:

- To add significantly to the development of the best and most promising researchers active in Europe, in order to enhance and maximise their contribution to the knowledge-based economy and society.
- The action will also strengthen the contact network of both the researcher and the host organisation.
- The fellowship will contribute to realising the full potential of researchers and to catalysing significant development in their careers in both the academic and non-academic sectors.
- Some researchers will be resuming a research career in Europe after a break, or reintegrating within Europe after living abroad.
