# 1. DISCUSSION POINT: SUSTAINABLE TRAVEL

As part of its Environmental Sustainability agenda, the University has produced a Sustainable Travel Plan (STP) to help reduce carbon emissions and to embed a culture of sustainable travel amongst staff and students. Working with local transport bodies, the University has invested in a number of schemes and initiatives to support this agenda, including:

- Cycling: new cycle parking and showers, a Bike User Group (UMBUG) and the tax free bikes scheme.
- Public transport: interest free loans for annual season tickets and the Oxford Road Link.
- Car travel: a low emission vehicle scheme and smarter driver training
- Walking & Running: A recently launched run-commute group and lunchtime walks.
- Business Travel: new videoconferencing suites and electric pool car

For this month's discussion topic, we would like to hear from you about what more the University can do to encourage more sustainable travel. Questions to prompt discussion:

- Are you aware of the schemes detailed above? Do you currently use any of them?
- What factors prevent you from using more sustainable forms of travel to reach work or travel on business?
- What do you feel the University could do to encourage more sustainable travel options?
- Are the planned public transport changes (e.g. Bus Priority scheme, smartcard ticketing, rail and Metrolink improvements, improved cycling infrastructure) likely to change your current travel arrangements?

## 2. FEEDBACK ON WORKING ENVIRONMENT

I'd like to thank everyone for their feedback on the working environment topic which clearly generated some lively discussion. A large number of comments and ideas have been submitted and these have been collated into one document and passed to colleagues in Estates to inform planning of our new buildings and refurbishment projects. Many staff were supportive of open plan workspaces provided that there was adequate provision of meeting rooms and social spaces, as well as small rooms for quiet working. Hot desking was a hot topic in itself with some colleagues in favour, but some others questioning whether it was the right approach for the PSS. Working from home was the other big topic with colleagues asking for a more consistent approach to be taken by the PSS leadership to this issue.

### 3. CHANCELLOR ELECTION

The names of candidates to be the next Chancellor of the University have been released. They are: Sir Mark Elder, CBE, Music Director of the Manchester Hallé Orchestra; The Rt. Hon the Lord Peter Mandelson, Labour peer and previous minister in the Labour government; and Lemn Sissay, MBE, the poet, broadcaster and writer from the North West. Voting will be open from Tuesday, 26 May to Thursday, 18 June with results being announced on Monday, 22 June. Staff (holding superannuable appointments), members of our General Assembly and alumni, who are registered with our Alumni Association, are eligible to vote in the election.

### 4. BENCHMARKING STUDY

As part of the continued emphasis on cost efficiency and value for money, the University has agreed to participate in a cost benchmarking exercise of its professional support services with a number of other Russell Group institutions. The Project is being led by Cubane, an Australian company with extensive experience in running similar projects. As the starting point for the project, all PSS pay costs have to be allocated against an agreed Activity Framework, to enable comparison of our costs with similar activity in other institutions. This will be a large-scale undertaking with several hundred staff required to complete the Activity Survey over the summer period. Training and guidance will be given. The results will be invaluable in helping us to understand our relative cost base and opportunities for improving efficiency. We are currently looking to recruit a Project manager to help with this Project. If you are interested, then please contact Helen Barton, Director of Planning.

IT Services are soon to undertake a large project to move one of the University's Data Centres to a modern and more efficient facility. This involves moving a large number of the computers and file servers from the Kilburn Building Data Centre to an offsite location over a number of weekends. ## 9. BARNES WALLIS HUB

The Barnes Wallis student hub, a new working space for students on the North campus opened to rave reviews last month. The new facility, which is based in the old Students' Union building includes; a new 'open access' computer cluster, individual and team working spaces, support and advice services and a cafe/informal learning space. The hub has been developed by colleagues from across the PSS working in collaboration with the Students' Union.

### 10. CAMPUS MASTERPLAN UPDATE

Progress on the Campus Masterplan continues apace with two significant completions in recent months, namely: the Whitworth Art Gallery, which re-opened on 14 February and was recently named the RIBA North West Building of the Year and North West Museum of the Year, and the National Graphene Institute, which opened in March. The Manchester Cancer Research Centre in Withington is scheduled to open in June.

Delivery of these major projects is a significant achievement involving many members of staff from the Directorate of Estates and Facilities and their considerable efforts are to be applauded. Elsewhere, site works have begun on the Manchester Engineering Campus Development with demolition of the Grosvenor Residences due to be carried out until around March 2016. Construction on this flagship development will begin next year. Preliminary excavation works are underway on Oxford Road as part of the MBS redevelopment to prepare for the demolition of the University precinct centre bridge later in the year. ## 12. STAFF SURVEY RESPONSE

An amazing 7, 177 people - 70% of all University staff - completed the recent Staff Survey. Thanks to all those PSS colleagues who helped us to achieve this remarkable response rate. Capita, which carried out the survey on the University's behalf, will now analyse the results and put together a range of reports. The results will be shared with staff early in June. In addition, three local charities will benefit to the tune of £7,177, with a £1 donation being given for each survey completed.
