## Who is an EEA Migrant Worker?

An EEA migrant worker is classed as a non-UK EEA national or a Swiss national in the UK who is, or was (in certain circumstances) working in the UK on either a full or part • time basis. You do not have to be a migrant worker on the first day of the first month of the first academic year of your course but you do have to have been ordinarily resident on that date.

# What is the difference between being an EU student and an

As an EU student, you would qualify for tuition fee support only. Please see our EU Student Factsheet for further information(www.studentsupport.manchester.ac.uk/ finances/a-z/student-finance-eu-students/). If you are an EU National and have been resident in the UK for five years before the first day of the first month of the start of your course, i.e. 1st September, 1st January and 1st April (whichever is closest to the start of your course) you may be entitled to the full Student Support Package.

- Ordinarily resident in the UK on the first day of the first month of the start of your course, i.e. 1st September, 1st January and 1<sup>st</sup> April (whichever is closest to the start of your course)
- Ordinarily resident in the EEA for three years prior to the commencement of the course.
- Authorised to work in the UK (Croatian workers only).

In addition, you must prove one of the following:

- Prior to starting your course you worked and you continue to work either full or part-time while studying. The number of hours is not defined however where only a limited number of hours are worked this may be an indication that the employment activities are purely marginal and ancillary therefore support would not be
- You have been working in the UK, stopped when you started your course, but you can demonstrate a link between your previous employment and your studies e.g. if you were working as a Health Care Assistant and you gave up your job to study a Degree in Nursing.
- You get a job after you have started your course and continue to work while studying. But remember you must also have been resident on the first day of the first academic year of the course.

## How do I apply for funding?

You should download the PN1 form for both fee and living Student Finance cost support from Student Finance England at www.gov.uk/studentfinance

You will also need to supply the following evidence:

- National Insurance Number
- Passport/National I.D. card (originals)
- Student bank account details
- Your income details
- Your parent's household income details- you should provide income details from the previous tax year i.e.
- All addresses prior to the start of the course

You will also be contacted by Student Finance to provide evidence of your employment status at the start of each term in order to continue to receive your funding.

## **Family Members**

As a family member of an EEA Migrant Worker, you may also qualify for financial support. Family members include:

- Spouse/civil partner
- Direct descendants under the age of 21 or dependant on the person or the person's spouse or civil partner
- Direct relatives in ascending line (parent or step-parent) or that of his spouse or civil partner (please note that this point does not include Swiss workers)
- Child of Turkish worker

## What support would I qualify for?

You may be able to apply for the following funding:

- Loans for living costs
- Tuition fee support
- Funding for any dependents
- Travel Grant
- Disabled Students' Allowance

If you qualify for this funding, it is important that you continue to work while you are studying or you may lose your status and therefore funding. It is also important to consider this if going on a placement/study abroad year.
