What constitutes previous study?

Student Finance will consider any time spent on a previous or equivalent qualification) Higher Education/Initial Teachers Training or any specifically There is no statutory funding for students who already have designated course that was provided by a publicly funded a degree or equivalent (or lower) qualification - even if this institution in the UK course as a full year's entitlement no was obtained overseas. Therefore you may only qualify for matter how long ago this was - even if:

- You only attended for 1 day
- You didn't apply for funding
- You studied overseas

Higher Education includes:

- Undergraduate degrees
- Postgraduate degrees
- Higher National Diplomas/Certificates (HND/HNC)
- Diplomas in Higher Education (Dip HEs)
- Certificates in Higher Education (Cert EDs)
- **Foundation Degrees**
- **Integrated Masters Degrees**

Student Finance Entitlement (if you previously started a • course but did not complete this)

In determining your financial entitlement, Student Finance • use the Standard Entitlement calculation. In essence this is:

Length of your course plus one extra ("gift") year

E.g. if you are studying a 3 year course, your entitlement would be 3 + 1 = 4 years

Any years of previous study at Higher Education level are then deducted from your new entitlement.

Which funding does this apply to?

- Tuition fee loans
- Tuition fee grants*
- **Bursaries and Scholarships**

*If applicable

Which funding might I still receive during any restricted vears?

- Disabled Students Allowance
- Childcare/Adults Dependents' Grant
- Parents' Learning Allowance
- Maintenance loan (as long as you didn't obtain a NHS Funding if you have previously studied at Higher qualification equal or higher to the one that you intend to Education level study)

The years that you are not entitled to funding are applied at the start of your new course so you would need to make arrangements to self-fund this period before you commence your course.

Student Finance Entitlement (if you already have a degree

'targeted support' which includes:

- **Disabled Students Allowance**
- Childcare/Adults Dependents' Grant
- Parents' Learning Allowance

However you would not be entitled to any:

- Tuition fee loans/grants*
- Maintenance loans

This is known as the Equivalent Level Qualification rule.

There are however some courses which are exempt to this rule which are:

- Social Work
- Medicine
- **Veterinary Science**
- Dentistry
- Architecture

The above courses allow you to apply for a Maintenance Loan however they do not include any grants and you will still need to self-fund for your tuition fees.

Students wishing to study a second honours degree in science, technology, engineering, mathematics or computer science on a part time basis will also be able to access a tuition fee loan. Nursing, Midwifery and Allied Health Professions as a **Second Degree**

Students studying a course in nursing, midwifery or AHP as a second degree are eligible to apply for Student Finance and the NHS Learning Support Fund.

If your previous course was not NHS funded, you may qualify for an NHS Bursary for NHS funded courses. These include:

- NHS funded year of a Medicine or Dentistry course
- Social work

How will I pay for my fees if I do not receive any support from Student Finance?

If you do not receive a fee loan from SFE, then you are Student Finance personally liable to pay the fees. You become liable as soon www.gov.uk/contact-student-finance-england as you enrol and therefore you must have made Bursaries arrangements before commencing a course to fund your www.studentsupport.manchester.ac.uk/finances/a-z/ studies.

University of Manchester Scholarships and Bursaries

You may qualify for one of the University of Manchester's bursaries/scholarships even if you do not qualify for Student Finance – all you need to do is request a financial assessment from them (even though you both know you will not receive any funding!) in order to allow the University to eligibility for support from us.

Financial Support Funds

If you need to clarify the level of an overseas qualification for Student Finance, you will need to contact the National Recognition Information Centre (UK NARIC) for verification: www.naric.org.uk/naric/

Are there other circumstances where SFE can ignore my previous study?

Yes. Study on a previous part-time HE course where no qualification was gained or study on an entirely self-funded* full time course, taken at a private institution, where no qualification was gained, may be fully disregarded.

* This is where no support of any kind was paid either to you, the university or college, to meet tuition fees or maintenance costs. If you have paid personally for a course but the charges were subsidised/reduced, for example, then this previous study would need to be disclosed as it would not be entirely self-funded.
