Archival history	This collection consists of materials collected by Lou Kushnick for research that would later be published in an article in the Journal of American Studies. The material was later donated to the centre.
Administrative history	<p>The New York City teachers' strike of 1968 was a confrontation between the new community-controlled school board in the largely black Ocean Hill–Brownsville neighborhoods of Brooklyn, and New York City's United Federation of Teachers. The strike started in May 1968 to November 1968, shutting down the public schools for a total of 36 days and increased racial tensions between Blacks and Jews.</p> <p>The community wished for more involvement in running the schools and a decentralization policy was initiated. This was contested by the United Federation of Teachers (UFT), led by Albert Shanker, who demanded the teachers' reinstatement. At the start of the school year in 1968, the UFT held a strike that shut down New York City's public schools for nearly two months.</p>
