

## Social Responsibility in the Curriculum Funding Call 18/19

*Apply for up to £2000 to enable socially responsible graduates through innovative curriculum enhancement*

**Application deadline:** Thursday 1<sup>st</sup> November 2018, 17:00

The FBMH Vice Dean for Social Responsibility, Prof Mahesh Nirmalan invites staff to apply for funding to support 'Social Responsibility in the Curriculum' initiatives. This has been successful in funding a range of initiatives in FBMH in the last two academic years, (further details at:

<https://www.bmh.manchester.ac.uk/connect/social-responsibility/> . Up to £1000 can be applied for (although funding up to £2000 will be considered in exceptional circumstances) and funding should be spent by 31<sup>st</sup> July 2019.

**Aim:** For course unit leaders to facilitate and encourage students to think how their enthusiasm for their subject can make a difference beyond the immediate demands of the curriculum.

### **Criteria:**

Any FBMH course unit leader of an undergraduate or postgraduate taught course can apply. Examples of proposals are not restricted to, but may include the following:

- Novel methods of involving and engaging patients and the public in curriculum development, teaching and assessment
- Incorporation of external visits or short placements in the curriculum to cultural and health venues, local charities, public sector bodies or schools
- Visits of relevant individuals or representatives of outside agencies to the module (i.e. patients, service users, service user researchers, patient groups, medical charities, community groups)
- Development of innovative assessment processes that orientate students to the outside world (e.g. challenging students to communicate research findings to an unexpected audience)
- Creation of course materials that promote students' work to non-university audiences
- Incorporation of student projects or commissions that challenge them to explore the relevance of their subject/discipline for engaging with wider communities (e.g. how might a module topic be used as part of wider community public engagement events?)
- Inclusion of Environmental Sustainability initiatives within the curriculum (e.g. considering environmental sustainability when designing new course content, reducing the need for travel, reducing the use of paper-based resources, etc.)

Those modules that incorporate activities that are targeted at increasing the employability of our graduates or highlight the relevance of patient and public involvement and engagement (PPI/E) and workplace ethics will be particularly welcome. Core modules will be given priority.

Costs can include:

- Student travel
- Visitor/speaker expenses
- Course materials
- Assessment material (e.g. posters, video)

Costs cannot include requests for IT equipment or other items which would normally be requested through your School equipment and resources budget.

A consortium of modules from the same programme could apply together where the activity may be jointly organised benefitting several groups of students (e.g. a speaker or a field visit) – however the maximum of £2000 would apply for a consortium as well. Individuals/consortium members can submit applications for more than one module.

**Funding awarded must be spent by 31<sup>st</sup> July 2019.**

To apply please submit a **two page summary** (two sides of A4 in 11ptCalibri font) and email to [srbmh@manchester.ac.uk](mailto:srbmh@manchester.ac.uk). The application form must not exceed two pages in total and requests information on the following:

- Project and module title, names of team members
- Timetable and student numbers
- Links to University social responsibility priorities

- Outcomes expected
- Evaluation plan
- Sustainability plan
