As you are aware, the NSS results are now out, and University results are available to colleagues using their staff login at the <u>TLSD NSS results website</u> along with a University analysis. The School has circulated its own initial analysis via email. A more in-depth School analysis will be undertaken after the merger with Law. In the meantime, congratulations to those areas that improved this year, the challenge for those areas that stayed the same is to raise their game. In those areas where there was a notable decline in satisfaction the School will support you in identifying what went wrong, and the actions that can be taken.

Staff Survey

As you know, the results of the University-wide staff survey have been published, and they make for both positive and disappointing reading. It is clear that there are many aspects of our working lives where the University is deemed to be good place to work but also many where it could be improved. I have attached the School level results to the bulletin, with the analysis distinguished by academic, research and PS staff. This is worth reading and thinking about. My feeling is that as a School we should not rush to come up with 'easy' answers — the survey results raise tough questions. So, over the remainder of the summer please think about possible actions we can take, and putting the right actions into practice will be a key focus for SLT, SPRC and the School Board from the next academic year onwards.

Graduation and Office Hours

The attendance of colleagues at this year's graduation ceremonies ranged from being quite good to appallingly bad and embarrassing. Thank you to those who did make the effort, and especially those who read out the graduating students' names. I have asked Heads of Departments to have a rota of attendees from next academic year onwards. It's disappointing that so many of us are willing to woo the students to come here, take their money and not to acknowledge their achievements at graduation.

What is even more disappointing, is the reports I've had of students turning up during office hours to find the member of staff is not in that day for no apparent reason. While this is only a very small number of staff it can't continue. From next academic year I will be asking HoDs to meet with staff who are not in attendance during their office hours to me, and to keep me informed.

Thanks for your support in my first year as Head of School, and for the hard work you've undertaken in all areas of activity. I hope you have a good break planned, and that you make the most of it. I know that many of you will be working over what's left of the summer, but I hope that you can do so in a more relaxed way than during teaching semesters.

Please ensure that all publications are deposited in the UoM repository (<u>Open Access</u> <u>Gateway</u>) within three months of acceptance. This applies to all publications, whether REF eligible or not.

Research Ethics Training

The University is implementing mandatory research integrity training for all staff who undertake research to take a 1-hour concise course by July 31st 2019.

Email Phishing

What is phishing?

Phishing is an email that tries to trick you in to giving out personal information, or visiting fake websites. Responding to a phishing attack can:

- Release your personal details to someone who may use them fraudulently
- Encrypt your files and folders, demanding that a 'ransom' fee be paid to revert the damage
- Stop your computer from working completely

People who engineer phishing scams are criminals and hackers.

Take the online phishing awareness course

The University has a short online course to help you identify these types of emails. The course takes fewer than 15 minutes to complete and is available to all staff and students via Blackboard.

Register for the email phishing course

Key check points

- Is the sender of the email someone you know?
- Does the URL it contains look legitimate? (Hover your mouse to check)
- Were you expecting an attachment?

Help!

If you think you're a victim of a phishing email, or that your PC has become infected, telephone us immediately on 0161 306 5544.

If you receive a suspicious email, do not click on any links and do not reply, but you should let us know by sending us the phishing email as an attachment:

Report phishing using Microsoft Outlook 2010

- Select the junk email message
- Click "More" (next to the "Forward" button) and select "Forward as attachment"
- In the new message window that pops up, send the email to: phishing@manchester.ac.uk

Report phishing using Outlook Web App

- Right-click (or Ctrl+click on a Mac) on the junk email message
- Click "Forward as attachment"

In the new message window that pops up, send the email to: phishing@manchester.ac.uk

You don't need to explain why you've sent the message. Everything we need to know will be in that attachment.

Never reply to suspected junk email, click any links or open any associated attachments (as these more than likely will contain viruses). Replying or clicking an 'unsubscribe' link could confirm to the sender that your email is in use and they will send you more. The only way to be completely safe is to delete any suspect messages.

British Academy Postdoctoral Fellow

Philosophy has a British Academy Postdoctoral Fellow, Dr Adriana Clavel, starting in the autumn. This is Manchester Philosophy's second BA Postdoctoral Fellow in as many years. Adriana got her PhD from Leeds in 2016 and since then has spent time as a visiting researcher at Leeds and a fixed-term lecturer at Hull. Her project is on the ethics of the imagination.

2020 ISA Environmental Studies Section Distinguished Scholar: Mat Paterson

I am delighted to announce that the recipient of the section's 2020 Distinguished Scholar Award is Professor Matthew Paterson. This award recognizes outstanding scholars whose long history of excellent research and teaching has had substantial impact on fields associated with international relations and environmental issues.

Matthew Paterson's scholarship, its breadth, depth, and quality, is simply remarkable. For over 25 years Mat has been at the forefront of the study of global environmental politics, exploring and making significant advances in areas of the global governance, political economy, and cultural politics of climate change and sustainability. Mat also exemplifies the identity of the teacher-scholar who cares deeply about pedagogy and mentoring students. He brings the same passion and curiosity to the classroom as he does to his research and he fosters wonderful relationships with his graduate students and postdocs, often publishing with them and treats them as true colleagues. Finally, Mat is a wonderful citizen for the ESS and scholarly community. He served as co-editor of *Global Environmental Politics* and remains a board member and crucial support for this flagship journal. He also served with distinction as an author for the IPCC and is a regular commentator on environmental issues for audiences beyond the academy.

Please join us at a roundtable and subsequent reception to celebrate Mat's contribution to the field at ISA 2020 in Honolulu (March 25-28, exact details TBA), and, even if you will not be there in person, in congratulating our latest distinguished scholar!
