1. Staffing News

As from 1 August, Ian Hutt took on the new role of Head of Digital Learning, moving from his role of Head of Distance Learning Operations supporting UMW. In his new role, he will be responsible for establishing and leading a University-wide digital learning service.

We are pleased to welcome our new Student Engagement Graduate Interns (Peer Support) - Eleanor Royle, Daniel Bayes, Jessica Hill & Flora Tickell who joined our Student Engagement and Success team at the end of August, for a period of 18 months.

In early September, we welcomed Janine Holdway, the new Teaching and Learning Manager (Policy) to replace Geoff Carter. Janine will be heading up the appeals and complaints and policy team within the office.

Steve Luddington took on the role of Acting Teaching and Learning Co-ordinator (Quality and Development) from 1st September, covering Kerry Jones' extended secondment and working on the full range of student surveys and the new survey frameworks.

Joanne Harvey joined us in September as an ELearning Support Officer in the Distance Learning Delivery team.

Ben Bone returned to the office in late September as Teaching and Learning Co-ordinator (Student Engagement), working on the Student Engagement and Success portfolio, including Peer Support.

Professor Judy Williams has been appointed to the new role of Academic Director for the Institute of Teaching and Learning, with effect from 1 October.

Lisa McDonagh, Teaching and Learning Adviser (Academic Development) will be starting with us in mid-October. Lisa will be working on the development of the new Institute for Teaching and Learning.

2. Website/policy and procedure changes

• Regulation XVII (Conduct and Discipline of Students) – owned by the Division of Campus Life

Following on from information in the June 2019 Bulletin, the new set of discipline policies falling under Regulation XVII (Conduct and Discipline of Students) have gone live as of the start of September. This includes the approved versions of the Procedure for Student Criminal Offences and the Procedure for Handling Allegations of Sexual Misconduct. The new documents have all been uploaded online to the University Documents system. The new policies can now be applied to incoming cases. You may wish to revisit your local letter and guidance templates to ensure you have the correct links and policy references e.g. academic malpractice is now referred to at 2r of the Regulation rather than 8k. If you have cases that have already been referred into the disciplinary process before the start of September (i.e. a referral being made as opposed to a case being investigated) then it is recommended that you apply the previous Regulation / Academic Malpractice: Procedure for the Handling of Cases (both of which are still online but on new links).

• Removal of the Guidance to Students on Plagiarism and other forms of academic malpractice, and Plagiarism and other forms of Academic Malpractice – Guidance for Staff

Following on from above, as a result of the updates to Regulation XVII (Conduct and Discipline of Students) and the new suite of associated policies from the Division of Campus Life, the original versions of the staff and student guidance documents on plagiarism and other forms of academic malpractice have now been removed from the TLSD website

• Principles and Guidance for the Application of the Accreditation of Prior Learning (AP(E)L)

An update has been made to the above document to amend the figure for the maximum number of credits which can be awarded under AP(E)L for the Postgraduate Certificate, relating to the move to 20 credit units for UMW courses.

Training


• We now have almost 2000 trained students in Peer Support leadership roles. We have now run PASS in your Discipline training for almost all of our PASS schemes across the University, which allows the PASS Leaders for the year ahead to come together for the first time, chat about the year ahead within their own scheme, and plan some fantastic events to bring them all together! Peer Mentoring schemes are coming along just as nicely, with over half of schemes having had Mentor Debrief training. This training session has changed slightly from last year, and allows a much more student based approach where they can start thinking about the upcoming year within their scheme.

• Before Welcome Week, we held two International Orientation sessions to welcome new students from across the globe to Manchester. We filled them in on the Peer Support opportunities at the University followed by group activities and some board games!
