	retribution.
	The decision was appealed and while the family awaited the
	outcome of the appeal Farhat made contributions to community life
	in Manchester.
	While trying to make her family financially independent she
	supported newly arrived asylum seekers and worked with the
	Manchester Refugee Support Network and the Cheetham Hill
	Advice Centre. In 2003 the asylum appeal was refused and Farhat's
	right to work was revoked meaning that Farhat had to leave her job
	and lose financial independence.
	When this appeal was rejected friends and colleagues set up the
	Farhat Khan and Family Must Stay anti deportation campaign. As
	part of this Farhat spoke all over the country, demonstrations were
	held in Manchester to raise the profile of the case and a petition of
	over 9,000 signatures was collected and presented to the Home
	Office.
	In 2004 Farhat was invited to Buckingham Palace in recognition of
	her contribution to national life through her work and volunteering.
	In 2006 she was invited to Downing Street by the Prime Minister in
	recognition of her voluntary contribution. Both of these invitations
	brought the case into the national press.
