• Student Surveys Update

#### Semester 2 Unit Surveys:

Colleagues will be aware that unit surveys for semester 2 have been running since the 27 April and will close next Monday, 18 May. You will be aware from previous communications that a decision was made to deploy these surveys with a revised question set, refocused so that students can provide feedback specifically about the changes they will have experienced to their teaching, learning and assessments when circumstances necessitated a rapid shift to online teaching and assessment.

We hope that the outputs will be helpful to us all in planning for potential delivery online next semester.

As is usual, colleagues in Schools responsible for overseeing survey activity will be able to access and disseminate the results for analysis from Tuesday 19 May.

Immediate concerns and actions should be recorded and fed into usual channels for example Teaching and Learning Committees, SSLCs, online spaces and SEAPs.

## National Student Survey (NSS) Publication Update:

The NSS closed on 30 April. Please liaise with your respective School contact regarding current internal response-rates as stricter limitations on this information mean that it cannot be shared in publications such as this that reach a wider audience.

The OfS have very recently announced that the NSS results will be published on **Wednesday 1 July 2020** with both public and provider datasets shared at the same time. TLSD will work with colleagues in Communications, Planning and TLG Executive to prepare for this and will share detailed plans for publication as soon as they are confirmed.

The UK funders and regulators will look at the data when received to assess any impact the coronavirus outbreak has had on the results and make professional judgements about its statistical reliability. Therefore, please note that this date is subject to change in response to the current coronavirus pandemic and updates will be circulated as they are received.

### Postgraduate Taught Experience Survey (PTES) Update:

PTES will remain open to our students until 15 June.

TLSD will circulate response-rate reports from this week (week commencing 11 May) to Faculty and School Teaching, Learning and Student Experience leads for onward dissemination. Please liaise with your respective School contact regarding current internal response-rates as stricter limitations on this information mean that it cannot be shared in publications such as this that reach a wider audience.

### • Taught Programme Approval Processes During the Coronavirus Outbreak Update

TLSD are currently developing revised processes, guidance and templates for amending, withdrawing and suspending programmes, and how to manage these changes when communicating with both existing students and prospective students that currently hold an offer with The University.

The changes in processes and guidance are intended to introduce a measure of agility and flexibility to our current approach and are intended to support colleagues in their commitment to continue to provide the highest levels of quality and student experience. Additionally they will enable colleagues to embed into provision for the next academic session some of the wonderfully innovative ways that teaching, learning and assessment activities have been adapted in response to the impact of the coronavirus outbreak. They are also intended to support colleagues when striking a balance between this, and remaining compliant with Competition and Markets Authority (CMA), the commitments set out in our Student Protection Plan and the legal requirements published in our Student Terms & Conditions.

These arrangements will be discussed for approval by TLG Executive colleagues when they meet on Wednesday of this week (13 May). The arrangements, guiding principles and modified templates will be published in a dedicated area of our TLSD webpages within the Academic Development and Policy section, and once approved will be circulated to Faculty Teaching, Learning and Student Experience leads for onward dissemination and further details around implementation.

# 6. Information from the Quality Assurance Agency (QAA)

 Quality Assurance Agency Resources: Maintaining Quality in Teaching and Learning During COVID-19

QAA is working rapidly to support the sector through the COVID-19 (Coronavirus) outbreak and are engaging with colleagues from across the sector, including student bodies, regulators and funders to support us in making necessary changes to learning, teaching and assessment.

QAA are supporting colleagues by:

- providing guidance on mitigating the impact on assessment, progression and graduation in coming academic years
- developing supporting materials on priority topics
- delivering regular webinars to support the sector in sharing practice (recorded and archived in our Membership Resources site)
- hosting the QAA Quality Discussion Forum where colleagues can debate and discuss challenges as well as sharing what has worked.
