#### Theory, Research and Policy

The conference will be unique in a UK context through seeking to bring together theorists, researchers and policy makers in higher education working on 'fair admissions' to competitive higher education institutions.

There has been a sustained drive by government and higher education institutions to improve the fairness of admissions procedures. Many leading universities have introduced new policies, which use measures of social and educational disadvantage as relevant factors in the admissions process. Concepts such as disadvantage, achievement, aptitude, potential, underrepresentation and social class have variously been used to justify such approaches. These practices raise three inter-related questions for the conference:

- 1) Normative questions: who should be admitted to leading HEIs?
- 2) Empirical questions: who is admitted?
- 3) Policy questions: how can 'fair admissions' be pursued in practice?

All too often, these three questions are answered by distinct groups – namely philosophers, empirical researchers and policy makers/practitioners respectively. This conferences bridges these divides and brings all three perspectives together. We invite empirical researchers, policy makers and theorists to contribute. Admissions discussions are furthermore frequently restricted to national contexts. We particularly welcome contributions with a comparative or international perspective.

#### **Application**

The unique feature of this conference is to bridge theory, research and policy. We will use an application process for delegates that will help us achieve an appropriate balance of these different perspectives. We therefore invite prospective delegates to send us up to 150 words describing how you and/or your organisation would benefit from participating in the conference, basic biographical information and your particular interest/perspective – i.e. theory, research or policy. The deadline for applications to attend is 10 December 2010 and should be sent to julian.skyrme@manchester.ac.uk
