PLEASE NOTE - when selecting your free choice course unit:

- Please note where a UCOL (University College) unit is a language unit, the LEAP rules below apply.
- MLBM Russian students may take one LEAP language unit (20 credits) as free choice in either or both of the second and final years, as long as in any one year no more than three languages are studied. However, a LEAP language unit may only be taken as a free choice unit in the final year if a prerequisite LEAP unit in the SAME language has been taken in the second year. You must apply directly with the LEAP office in order to take a LEAP language unit. (Your performance on this unit will be monitored, and, where relevant, you may be advised to discontinue with the study of a third language in the subsequent year of study at the recommendation of your Academic Advisor or Programme Director.)

Important Notes

- At least 100 of the total of 120 credits must be at Level 3 (i.e. course units whose code numbers begin with the number 3, e.g. BMAN31031), but up to 20 of the 120 credits can be at Level 2. You may NOT take any credits at Level 1 (i.e. course units whose code numbers begin with the number 1).
