Regulations:

- All Level 1 Modern History with Economics (MHE) students will be automatically enrolled on HIST10101 History in Practice (20 credits), HIST10182 Capitalism in Historical Perspective, 1700 – 1913 (20 credits), ECON10221 Microeconomics 1 (10 credits) and ECON10252 Macroeconomics 1 (10 credits)
- All Level 1 MHE students with GCSE but NOT A Level mathematics and statistics will be automatically enrolled on ECON10061 Introductory Mathematics (10 credits) **AND** SOST10062 Introductory Statistics (10 credits).
- All Level 1 MHE students with A Level mathematics and statistics will be automatically enrolled on ECON10071B Advanced Mathematics (10 credits) **AND** ECON10072 Advanced Statistics (10 credits)
- All Level 1 MHE students must choose 40 additional credits of optional course units (Lists B – C)

After following Steps 1 to 4 below, all Level 1 MHE students must have:

- Total selection of exactly 120 credits
- Minimum of 50 credits of course units in each semester
- Maximum of 70 credits of course units in each semester
- Selected units whose lectures do not clash

Note on Credit Allocation Across Semesters:

- The semester in which a course unit is taught is identified by the last digit in the course code (eg HIST10101 = semester 1). A 0 (zero) final digit indicates the course unit is taught across both semesters
- When calculating your credit allocation by semester, the credits for 0 (zero) coded courses should be divided equally between semester 1 and semester 2

Note on BMAN Course Selection (BMAN courses are available on List C below)

- MHE students must complete the School of Social Sciences (SoSS) and AMBS (BMAN) Course Selection Process, which may open on separate dates to HIST courses, to register for all SoSS and AMBS course units, including ECON- and POLI-coded course units.
- Please note that some AMBS accounting and finance units have assessment which needs to be completed on campus due to professional accreditation/exemptions.

Please note that swapping or dropping full-year optional modules is prohibited after week 2 of semester 1.
