





PROFESSOR A.O.A. IBHADODE



Professor Akaehomen O. Akii Ibhado is the **current Vice-Chancellor of the Federal University of Petroleum Resources, Effurun (FUPRE), Delta State, Nigeria** (<http://www.fupre.edu.ng/>) and a Professor of Manufacturing Engineering at the University of Benin, Benin City, Nigeria. He was Head of Department of Production Engineering (1992 – 1995, 2001 – 2004) and Dean of the Faculty of Engineering (2004 – 2008). **He is a Fellow of the prestigious Nigerian Academy of Science.**

Professor Ibhado obtained his B.Sc. degree in Mechanical Engineering from the University of Lagos in 1981, M.Eng. in Manufacturing Engineering from the University of Benin in 1984, and his Ph.D in Mechanical Engineering from the University of Birmingham, United Kingdom in 1987 specializing in Die Design. One of his research papers titled **“Effects of billet location in completely closed cavity die forging”** arising from his Ph.D. work won the **Edwin Walker Prize for 1988 of the Institution of Mechanical Engineers, United Kingdom.**

His research interests include Die/Mould Design, Metalforming, Metalcasting and Joining Processes, Materials, Production Management, Artificial Intelligence, Entrepreneurship and SME Development. He has developed new products and processes among which are new formulations for steel and aluminium welding fluxes, structural materials from oil palm waste processing, development of various machinery for processing of a traditional meat delicacy and other products, and a new method for the design of precision dies and moulds. A book titled **“Precision Die Design by the Die Expansion Method”** presents the new die/mould design method. **This work won him the Nigeria Prize for Science 2010 of the Nigerian Academy of Science sponsored by the Nigerian LNG Limited.** He has supervised over seventy M.Sc. and Ph.D. students.

He is a research consultant to many agencies. **He is the Founder and Editor of the International Journal of Engineering Research in Africa (JERA)** published in Switzerland and Member of the Editorial Board of the international journal of **Advanced Materials Research (AMR).**

He is currently driving research work in FUPRE in the areas of upgrade of local refineries/distillation plants, oil & gas pipeline integrity and surveillance, mitigation of environmental impact of oil & gas activities, electricity from biomass, design of fuel-efficient vehicles among others.

Professor Ibhado is Patron/Chairman of a number of organizations, member of the Nigerian Society of Engineers and a chartered engineer.

Irene Okhade is a Civil Engineering graduate (University of Benin, Nigeria) with a masters in Management and Implementation of Development Projects (University of Manchester). **She is presently a PhD research student at the Institute of Development Policy and Management, the University of Manchester.**
