### The University's eThesis access policy

The University's [Presentation of Theses policy](#) requires that all final Postgraduate Research eTheses are made Open Access no longer than 12 months after submission, unless an exception to the policy is required for reasons of sponsorship or sensitive content.

PGR students select their preferred access level for their final eThesis when completing submission of their examination thesis. PGR supervisors are required to check and either approve or override this preferred final thesis access levels, based on the supervisor's awareness of the policy, thesis content, and sponsor or research partner requirements.
