# **Final Year**

#### **Optional Units**

# 40 credits from among the Politics Level 3 course units. Examples include:

Politics of the European Union, Russian Politics, The Politics and Philosophy of Nationalism, Gender, Sex & Politics, Elections and Voters in Britain, Public Policy Problems, Political Ideologies in Modern Britain, International Political Economy, The Politics of Climate Change, Postcolonial Politics, International Political Economy of Trade, United Nations Security Council in Practice.
