#### Annual Report of Student Appeals, Student Complaints and Student Discipline Cases 2019-201

#### **Section 1: Executive summary**

The Annual Report details the number and nature of formal academic appeals, complaints, discipline and fitness to practise cases handled each academic year and is required under the Regulations for the relevant areas. The data reported below relate only to formal cases and do not include cases which are resolved informally.<sup>2</sup>

The overall number of cases across the different Regulations represents a small proportion of the total student population (1.44% in 2019-20).

In relation to academic appeals we continue to see a significant decrease in the number of formal stage cases from 409 in 2017-18 to 315 in 2018-19 and 262 in 2019-20. However the number of formal complaints received by Faculties saw an increase from 79 in 2018-19 to 113 in 2019-20.

The number of formal appeals received by the Faculty of Biology, Medicine and Health (BMH) continues to be higher than the other Faculties with 44% of all appeals being received in this Faculty. However it is pleasing to see a gradual fall over previous years from 59% to 51% and now 44%. The work undertaken by the Division of Teaching, Learning and Student Development (TLSD) to clarify the purpose of the 'informal stage' seems to be having an impact.

There has been a significant increase in the number of students submitting cases to the Office of the Independent Adjudicator (OIA): 104 cases in 2019-20 compared with 57 cases in 2018-19 and 48 in 2017-18. This was chiefly due to a large number of students (44) attempting to take complaints to the OIA regarding the impact of industrial action and/or COVID-19 without first completing the University's internal procedures. As in previous years, the OIA found the vast majority of complaints they received about the University of Manchester to be Not Justified. However four cases were found to be Justified.

Previously Senate recommended a case review of academic appeals and malpractice cases to help us understand some of the data in relation to BAME and international student data in this annual report. Professor Aneez Esmail, member of Senate, acted in an advisory capacity during the case review and report writing. There are a substantial number of actions relating to consistency of systems and procedure, which will be achieved in full via the role of standard online procedures and forms for appeals, complaints and discipline as a result of SEP systems roll out. This will provide a more responsive, timely and consistent student experience, whilst enabling us to collect and analyse and respond to data more effectively. The report makes recommendations around the accessibility of mental health support for students, which has been substantially enhanced in Manchester with the opening of the Mental Health Hub. In reference to a recommendation on consistent monitoring of student engagement and attendance, the University is launching a new App, to support consistent engagement monitoring, which will support colleagues in identifying students in need of support at an earlier point, allowing us to intervene before they find themselves having to participate in the appeals or disciplinary procedures. Finally, the report makes recommendations for staff training for staff involved in discipline panels, the design of which is underway. Further commentary is included in Section 4 of this report.



In 2019-20 academic year, four cases resulted in compensation at the Faculty stage, an increase from one case the previous year. The most common resolution was an apology or explanation in respect of the circumstances which led to the complaint.

#### **Accommodation Complaints**

Whilst many Regulation XVIII complaints are submitted via Faculties, complaints regarding accommodation are submitted directly to Residential Services. In 2019-20 complaints to Residential Services increased from 46 to 57.


The four cases where decisions were altered resulted in the following outcomes:

- A fee waiver of £465
- The Library agreed to review how students' support plans were shared with appropriate library colleagues
- Development of a University student maternity/paternity policy for UG and PGT students
- Case was referred to a complaints panel for consideration

The Division of Teaching, Learning and Student Development also reviews complaints against the Students' Union which have been dealt with under the Students' Union Code of Practice. No review requests in relation to such complaints were received during the 2019-20 academic year.

After the review stage, the University of Manchester procedures are completed and students are issued with a Completion of Procedures letter, as required by the Office of the Independent Adjudicator.

As can be seen from the data above, there continues to be a steady decrease in the total number of formal academic appeals being received by Faculties, from 315 in 2018-19 to 262 in 2019-20. The number of formal appeals received by the Faculty of Biology, Medicine and Health (BMH) continues to be higher than the other Faculties with 44% of all appeals being received in this Faculty.

BME students make up 17.6% of the student population but constitute 27% of appellants whilst International students make up 39.5% of the student population but this year constituted 33% of appellants. This is a considerable change from the previous year where the proportion of International students appealing was higher than their % population by 8.4%.

We have previously reported on the difference in appeal outcomes between white and BME home students and International students. The position for 2019-20 shows a marked change. The following table shows the comparator data for 2018-19 and 2019-20.

Appealing against a degree classification or the qualification awarded has overtaken exclusion due to academic failure as the most common single reason for appealing, although the composite category of 'other' contains the largest number of cases overall (this category includes appeals against individual assessment marks for example).

The number of appeals dismissed on the basis that they are invalid, as allowed for by paragraph 5 of Regulation XIX, decreased again in 2019-20 seeing a fall from 28% in 2017-18 to 15% in 2019-20. A formal appeal may be dismissed from the outset because it has not been made in time, because it is considered to be a challenge to academic judgement or because it does not meet a pre-condition for an appeal on a particular ground (for example, the Faculty may consider that an appeal made on the ground of mitigating circumstances should be rejected because the student has not offered a credible and compelling reason, with supporting documentation, explaining why they did not utilise the mitigating circumstances procedure prior to receiving their results).

85 out of the 94 upheld appeals (90%) were made on the ground of mitigating circumstances. An upheld appeal does not necessarily mean that the original decision was incorrect but more commonly means that late mitigating circumstances evidence has been provided which may have affected the Exam Board's decision if the evidence had been made available earlier.

#### **Review of Faculty Decision**

39 students requested a review of their academic appeal (Regulation XIX, paragraph 10) by the Director of Teaching, Learning and Student Development during the 2019-20 academic year.



There was an increase in the number of cases that were taken to review stage in 2019-20 which resulted in the previous decision being altered in some way, compared to the previous academic year (26% compared to 16% in 2018-19). Most commonly, the alteration took the form of a recommendation that Schools were asked to reconsider the case. In three cases where the decision was upheld, Faculties were advised to make compensation payments to the students due to delays in the Faculty's handling of the appeals.

After the review stage, the University of Manchester procedures are completed and students are issued with a Completion of Procedures letter, as required by the Office of the Independent Adjudicator.

#### Section 5: Commentary on Conduct and Discipline of Students (Regulation XVII)

Conduct and Discipline cases may relate to either academic malpractice or non-academic misconduct and are handled in a variety of different locations within the University depending on the nature of the offence, the seriousness of it, the student's previous history etc. Previous Senate Reports have focused primarily on cases handled by Faculties, the University Disciplinary Panel and those handled by a Summary Discipline Panel in relation to exam misconduct. For the purposes of comparison with previous years, figures for these types of cases are given first below, followed by cases handled by other areas of the University. The Student Conduct and Discipline Committee, chaired by the Vice-President for Teaching, Learning and Students, maintains an overview of training for panel chairs, diversity of panel members, and issues arising from cases.

In 2019-20 the number of Faculty cases rose by one and there is no evidence of an upward trend over time. Plagiarism remains the largest proportion of cases dealt with at Faculty level. The split across the demographics has changed this year with White students being slightly the more likely demographic of students to be involved in instances of academic malpractice.

90% of students whose academic malpractice case was referred to a Faculty were found guilty, and most of these were either given a mark of zero for the specific piece of work or course unit in which the unfair practice occurred or a reprimand and warning.

#### **University Disciplinary Panel Cases**

Cases of academic malpractice or non-academic misconduct deemed to be particularly serious, or where the student has a previous disciplinary record, may be referred to a University Disciplinary Panel. These panels are organised by the Division of Campus Life. The membership of each panel is drawn from a list of colleagues nominated by each Faculty and approved by the Student Conduct and Discipline Committee. Faculties are asked to ensure diversity in the nominations put forward.

Where a student is found guilty by the UDP, penalties tend to be more severe than for cases dealt with at a lower level. Two students were expelled during 2019-20 following a UDP, another was excluded for 12 months and one was asked to undertake 40 hours of community service across the University.

#### **Summary Discipline (Exam Misconduct) Cases**

When a student is suspected of possessing unauthorised material in a centrally arranged University exam, these cases are usually dealt with by a Summary Disciplinary Panel organised by the Exams Team in the Division of Student Admissions and Administration.

One of the six cases was dismissed. For the remaining five cases, the case against the students was confirmed with the most common penalty being a mark of zero for either the exam or the course unit as a whole. There was a significant reduction in the number of cases due to the movement of semester two examinations online as a consequence of COVID-19.

#### **Discipline (Residential Services) Cases**

This is the second year this dataset has been included in the Senate Report. The Division of Residential Services undertakes discipline cases in respect of misconduct in halls. Data for 2019-20 is detailed below.

Of the 313 cases 20 students were found not to have breached the regulations following the disciplinary hearing compared with only two out of 404 in the previous year. Of those found to be in breach no students were expelled from their accommodation compared to two in the previous year.

Fines totalling £23,610 were issued during the academic year compared to £44,365.99 the previous year - £12,120 of which related to drug related offences.

#### **School Cases**

Except in severe cases, Schools tend to handle instances of first offence UG and PGT academic malpractice and may also handle some instances of non-academic misconduct. Plagiarism remains the most common type of misconduct that Schools investigate. The TLSD requests data from Schools on the cases heard by them for inclusion in this report. The data collected from Schools is detailed below.<sup>7</sup> A comparison to last year is also included for the first time.

#### Appeals against conduct and discipline decisions

After the appeal stage, the University of Manchester procedures are completed and students are issued with a Completion of Procedures letter, as required by the Office of the Independent Adjudicator.

#### Section 6: Commentary on Fitness to Practise<sup>8</sup>

Fitness to Practise cases originate in the Faculty of Biology, Medicine and Health (BMH) because of the nature of the programmes of study undertaken in that Faculty. Fitness to Practise cases can arise for a variety of reasons, which often relate to matters of health and professional conduct. BMH School Health and Conduct Committees have the power to refer a student to a Fitness to Practise Committee.

Due to the length of time over which a Fitness to Practise case can run, and to reflect a clearer picture of outcomes, the data presented below is based on the number of Fitness to Practise Committee hearings that took place during the 2019-20 academic year.



Appeals against a decision of a Fitness to Practise Committee can be made on the grounds of disproportionate outcome, procedural irregularity and/or the availability of new evidence. During the 2019-20 academic year, two appeals were submitted to the Division of Teaching, Learning and Student Development. In both cases the original decision of the Fitness to Practice panel was upheld at review.

After the appeal stage, the University of Manchester procedures are completed and students are issued with a Completion of Procedures letter, as required by the OIA.

Section 7: Commentary on cases taken by students to the Office of the Independent Adjudicator (OIA)



The OIA is appointed as the national independent body to consider student complaints. Usually, a student needs to have completed a University's internal procedures before taking a case to the OIA. The OIA has no regulatory powers over universities and cannot punish or fine them; however universities are expected to act upon its recommendations. The Division of Teaching, Learning and Student Development acts as the University's point of contact for the OIA.

The number of complaints made by students to the OIA continues to rise almost doubling from 57 in 2018-19 to 104 in 2019-20. However, 44 of these were students attempting to take a complaint to the OIA about industrial action and/or COVID-19 before completing the University's internal procedures. The anomaly seen during the 2015-16 academic year can be attributed to the OIA changing its timeframe for complaint submission from 3 months to 12 months.

Four of the cases submitted to the OIA during the 2019-20 academic year were found to be Justified, with a further two cases found to be Partly Justified.

In the Justified cases the OIA made the following recommendations:

 Offer £5000 compensation in view of the student's personal circumstances and the University's handling of the complaint

- Student to be offered the choice of two options a review of the Faculty complaint or £2000 compensation for distress caused
- Provide an apology and £250 compensation for distress and inconvenience
- Offer to refer the case back to the examination board and £500 for distress and inconvenience.

In the Partly Justified cases the OIA made the following recommendations:

- Offer £250 compensation for distress and inconvenience caused by the delay in processing the appeal
- Apologise and offer £1500 compensation for failings identified in the OIA outcome this case was a partner institution with £1000 of the compensation being paid by the college


The University agreed to settle two cases and made the following offers to students as a result:


- £250 compensation for the distress and inconvenience caused during the appeal process
