

#### Service Evaluation of Lateral Flow Device testing for COVID-19 in asymptomatic individuals

#### **Participant Information Sheet (PIS)**

You are being invited to take part in an evaluation project by the Department of Health and Social Care (DHSC). This project is part of DHSC's ongoing evaluation of delivery of Lateral Flow Device (LFD) testing for COVID-19 in individuals who do NOT have symptoms of COVID, and is part of a wider DHSC approach to QA (Quality Assurance) and testing how good LFDs are.

Before you decide whether to take part, it is important for you to understand why the evaluation is being conducted and what it will involve. Please take time to read the following information carefully before deciding whether to take part and discuss it with others if you wish.

## About the evaluation

#### Who will conduct the evaluation?

The University of Manchester's Asymptomatic Testing service will continue to perform the tests with the addition of another test. Anyone participating in the ongoing evaluation study will provide two samples, one which will be analysed via LFD (representing the standard of care for the site and official test) and one via qRT-PCR (AKA 'PCR'), the QA test). Only DHSC will have the results of both the LFD and the PCR test.

#### What is the purpose of the evaluation?

The study is being run as a quality assurance exercise as part of broader set of evaluation activities to ensure that that the LFDs are working well. As such, the objectives of ongoing evaluation studies are to measure how well the LFDs work when compared to standards achieved in previous studies used to evaluate performance of devices.

Please note: You will only receive results from the LFD test, while the QA test will be used to determine performance of the LFD in a given setting.

#### Will the outcomes of the evaluation be published?

We will not be publishing any results because The University of Manchester will not receive any results that can be linked to you.

#### Who has reviewed the evaluation project?

This has been designed and implemented by DHSC as service evaluation and advice sought by the Health Research Authority.

### What would my involvement be?

#### What would I be asked to do if I took part?

Anyone who doesn't have symptoms of COVID and is eligible for LFD testing at Asymptomatic Test Centres can take part in the ongoing evaluation study. Anyone participating in the ongoing evaluation study will provide two samples, one which will be analysed via LFD and one via PCR test.

You will only receive results from the LFD test, while the QA test will be used to determine performance of the LFD in a given setting. Please note that your LFD may not always pick up that you have COVID and so it is important to ensure that you always adhere to the national guidance, including "hands, face, space" and "stay home, save lives, protect the NHS".

You can opt out of the ongoing evaluation study and only provide one sample for the purposes of LFD testing as per the standard protocol. As we roll out the mass testing programme we are asking people to provide two samples. This allows us to continue evaluating different testing methods to ensure we are delivering a high standard of clinical service.

#### ➤ What happens if I do not want to take part or if I change my mind?

It is up to you to decide whether or not to take part. When you register for the test at the testing site you will be asked to give your consent. If you do decide to take part, you will be given this information sheet to keep and the person at the registration desk will complete an online consent form. If you decide to take part you are still free to withdraw at any time without giving a reason and without detriment to yourself. This does not affect your data protection rights. If you decide not to take part you do not need to do anything further.

## **Data Protection and Confidentiality**

#### What information will you collect about me?

In order to participate in this evaluation project The University of Manchester will not be collecting any data. Only the data you provide for booking your test and then registering to the NHS Test and Trace system will be needed and no-one at The University of Manchester can link this to your test results.

#### Under what legal basis are you collecting this information?

When booking in for your test, we are collecting and storing this personal identifiable information in accordance with UK data protection law which protects your rights. These state that we must have a legal basis (specific reason) for collecting your data. For this study, your booking information will not be linked to your test result at any time.

#### What are my rights in relation to the information you will collect about me?

You have a number of rights under data protection law regarding your personal information. For example you can request a copy of the information we hold about you.

# ➤ Will my participation in the study be confidential and my personal identifiable information be protected?

In accordance with data protection law, The University of Manchester is **not** the Data Controller for this project.

When you agree to take part in this evaluation project, and with your informed consent, the information about you will be analysed by DHSC for ongoing evaluation of the LFD. The University of Manchester will not have access to this information. The information will only be used for the purpose of evaluation, and cannot be used to contact you regarding any other matter.

Please also note that individuals from DHSC or regulatory authorities may need to look at the data collected for this study to make sure the project is being carried out as planned. This may involve looking at identifiable data that you will have provided to NHS Test and Trace. All individuals involved in auditing and monitoring the study will have a strict duty of confidentiality to you as a participant. The University of Manchester does not have access to this information.
