

# Make Movement Your Mission: Evaluation of an online physical activity programme

## **Participant Information Sheet (PIS)**

You are being invited to take part in a research study to evaluate an online physical activity programme, Make Movement Your Mission. Before you decide whether to take part, it is important for you to understand why the research is being conducted and what it will involve. Please take time to read the following information carefully before deciding whether to take part and discuss it with others if you wish. Please ask if there is anything that is not clear or if you would like more information. Thank you for taking the time to read this.

#### About the research

#### Who will conduct the research?

Dr Lisa McGarrigle, Research Fellow in the School of Health Sciences at the University of Manchester.

## > What is the purpose of the research?

In recent years, and especially since the onset of the COVID-19 pandemic, there has been a move toward online approaches for the delivery of services and supports to older people. Make Movement Your Mission (MMYM), run by Later Life Training (a not-for-profit training provider), was established in response to concern about high levels of inactivity and reduced social support amongst older people who may be shielding. The purpose of this study is to conduct an evaluation of MMYM by administering a survey to MMYM participants. We are especially interested in the ways in which people engage with the service and the impact participation is having on overall activity levels, health, quality of life, and social connection. We are also interested in learning about the kinds of technologies participants use to access the service, and how often they use the internet generally.

You have been invited to take part in this study as you are a member of the MMYM Facebook group and have experience participating in the regular "movement snacks" provided through the Facebook group and/or YouTube.

## > Will the outcomes of the research be published?

We will summarise our findings from this survey and share a brief report on the MMYM Facebook group. Findings will also be published in an academic journal and presented at academic conferences. All data provided by you will remain anonymous.

# > Who has reviewed the research project?

This study has been reviewed and approved by The University of Manchester Proportionate Research Ethics Committee (Reference number 2021-11259-18280).

## > Who is funding the research project?

This study has been jointly funded by the Manchester Institute for Collaborative Research on Ageing (MICRA) and the Centre for Ageing Better.

## What would I be asked to do if I took part?

If you decide to take part, we would like you to complete the online survey by clicking on the link in the advert posted to the MMYM Facebook page. This will take you to the online survey where you will be asked to confirm your consent to participate by ticking a box. Once you confirm consent you can begin completing the survey. Most questions are multiple choice and will simply involve ticking a box to indicate your response. Some questions are openended and allow you to type your response in a box provided. The survey will take approximately 15-20 minutes to complete. All of the information you provide in the survey will be kept confidential.

It is possible that you may find some of the survey questions related to social isolation or loneliness upsetting. Age UK provide a number of resources that can offer support, such as telephone befriending services. A list of resources can be found at the following weblink -

# Will I be compensated for taking part?

You will not be compensated for taking part in this research.

# What happens if I do not want to take part or if I change my mind?

It is up to you to decide whether or not to take part. Please feel free to discuss the study with others first before deciding whether or not to take part. If you do decide to take part you may download a copy of this information sheet to keep and can access the survey via the link posted on the MMYM Facebook page. At the beginning of the survey you will be presented with a consent form and will be asked to tick a box to confirm consent. If you decide to take part you are still free to withdraw at any time without giving a reason and without detriment to yourself. However, it will not be possible to remove your data from the project once it has been anonymised as we will not be able to identify your specific data. This does not affect your data protection rights. If you decide not to take part you do not need to do anything further.

# **Data Protection and Confidentiality**

# > What information will you collect about me?

In order to participate in this research project we will need to collect information that could identify you, called "personal identifiable information". Specifically, we will need to collect:

• Age, sex, country of residence, and ethnicity

# > Under what legal basis are you collecting this information?

We are collecting and storing this personal identifiable information in accordance with UK data protection law which protect your rights. These state that we must have a legal basis (specific reason) for collecting your data. For this study, the specific reason is that it is "a public interest task" and "a process necessary for research purposes".

# What are my rights in relation to the information you will collect about me?

You have a number of rights under data protection law regarding your personal information. For example, you can request a copy of the information we hold about you.

If you would like to know more about your different rights or the way we use your personal information to ensure we follow the law, please consult our <u>Privacy Notice for Research</u>.

# Will my participation in the study be confidential and my personal identifiable information be protected?

In accordance with data protection law, The University of Manchester is the Data Controller for this project. This means that we are responsible for making sure your personal information is kept secure, confidential and used only in the way you have been told it will be used. All researchers are trained with this in mind, and your data will be looked after in the following way:

Only the study team at the University of Manchester will have access to your personal information. Your name and contact details will not be collected as part of this survey and all data provided in the survey will be linked to a random ID number. This information will not identify you and will not be combined with other information in a way that could identify you. The information will only be used for the purpose of evaluating the MMYM programme and cannot be used to contact you regarding any other matter.

Anonymised data will be held for a maximum of five years after the study has been completed to allow us to publish our findings. Data will be stored using the University of Manchester Data Storage Service. Your individual data will not be shared with anyone outside the research team.

Please also note that individuals from The University of Manchester or regulatory authorities may need to look at the data collected for this study to make sure the project is being carried out as planned. This may involve looking at identifiable data. All individuals involved in auditing and monitoring the study will have a strict duty of confidentiality to you as a research participant.
