# Internal & External Context

- Firmer basis for planning, provided no last minute shifts in government policy.
- Managing implications of over-recruitment against target last year and continuing to juggle staff resource and physical capacity constraints.
- Competition for places this year will be further heightened by:
  - Growth in applications for undergraduate courses
  - Expectations regarding grade inflation potentially beyond the level witnessed last year
  - A continued paucity of gap year options reducing the likelihood of deferral
- Challenge in forecasting number of students who might successfully appeal or meet offer conditions through the Autumn exam period.
- Uncertainty re format of next academic year planning socially and nonsocially distanced timetables and remote study options.



# **UoM Admissions Position**

- Overall applications for undergraduate study have increased 11% relative to last year.
  - Applications from home UK-domiciled students have increased by 6%
  - Applications from international students increased by 38%
- Proportion of students accepting Manchester as firm choice consistent with previous years.




Table 1: % change to national and competitor UCAS applications entry 2021



# **Confirmation Strategy**

- All students meeting the conditions of their offer will be accepted.
- Absence of Student Number Controls gives us flexibility to admit students who have narrowly missed entry requirements in a small number of discipline areas.
- Will be flexible where possible but need to mitigate risks of overrecruitment on the staff and student experience.
- We will seek to maximise our recruitment of WP students given the disadvantages many have faced throughout the pandemic.
- We expect to make targeted use of Clearing.



# Widening Participation

- We will look to prioritise WP students in our confirmation decision processes .
- The impact of calculated grades on WP students' acceptances will be monitored
- Courses in Clearing will have a contextual offer -typically one grade lower, which will be published alongside our clearing offer for home students
- Designated staff will be on hand to speak to students participating in our Access programmes

### **Process of confirmation**

- The majority of students will have a decision processed by 8.30am on Tuesday 10<sup>th</sup> August
- Students just need to log on to Track there is no need to call us in the first instance
- Possible outcomes:
  - **UF** their place is confirmed and we'll be in touch
  - Unconditional Change Course Offer we haven't been able to accept them on their chosen course but can on an alternative. Students can accept/decline this via Track or call us for further details.
  - **Rejection** we have not been able to accept the student. They should check their insurance offer (if they have one) and then clearing listings.
  - No change they should contact us for an update and have their results to hand.



### Clearing

- We are operating a hotline as normal and intend for this to be on campus.
- A central hotline acts as a triage and passes eligible callers through to School admissions teams.
- Students should be directed to our clearing webpage <u>www.manchester.ac.uk/clearing</u> - this has real-time vacancies so it is important students check this just before calling.
- We can only discuss places with students who have collected/received their results.
- Applicants will be advised if they need to refer themselves by a specific deadline. Their oral offer will also be confirmed by email.

Before calling, students should check they have:

- ✓ Their exam results
- Their UCAS Personal ID
- The name and UCAS course code for the course they're interested in





### Appeals

- Students should consider carefully if appealing is the right choice for them and should be aware that on appeal, grades could go up, down or stay the same. The exam board's decision will be final so if their grade is lowered, they will not be able to revert back to the original grade they received on results day.
- If a UoM offer holder chooses to appeal, we are going to ask students to complete an online form to notify us of this. Once they have submitted the form they will receive an email confirmation that we have received this information. We will only take submission of the form as official notification that you are appealing so they do not need to contact us via phone or email to inform us of this.
- Once the student has received their appeal outcome, we ask them to notify the admissions team in the relevant Academic School as soon as possible.



### Appeals

- We would expect to honour places where applicants meet the conditions of their offer by 8th September (with the exception of Medicine/Dentistry - 31 August)
- If the student receives an outcome after 8 September (or 31 August), they should contact the academic School as soon as possible to discuss their application. The School will decide, at their discretion, whether they are able to offer them a place for September 2021 as a result of their new mark(s). If we can't offer them a place for the year of entry that they applied for, we would probably make them a deferred offer for the following year's entry, or offer admission to another course.
- Please note that if we make a student an offer for deferred entry in the following year, they'll be required, prior to taking up their place, to re-take the medical fitness assessment and repeat the DBS check for courses, where these requirements apply.



### Sitting exams in a future exam series

- Applicants who choose to sit examinations at a later date would be required to reapply in the 2022 cycle but would be guaranteed to receive an offer providing they hold a conditional firm or insurance offer holder with us this year (please see an exemption and specific guidance for Medicine and Dentistry).
- Guaranteed offers would only apply to the specific course for which an offer is held this cycle, for example if they are holding an offer for English Literature, their guarantee would only apply for English Literature next year.
- The guarantee would result in an offer at the 2022 entry requirements, though Schools may honour 2021 conditions at their discretion.
- Students would not be required to attend another interview or resit any aptitude tests, such as UCAT, but some students may be required to satisfy non-academic conditions such as a DBS check or a health screening. The results obtained from the future sitting would be classed as their first attempt as opposed to a resit.



# Sitting exams in a future exam series – Medicine and Dentistry

We strongly encourage students to sit exams in the relevant subjects as soon as possible. Applicants holding a conditional firm offer are guaranteed to receive an offer for 2022 entry, provided they sit exams in the next available exam series. A new UCAT or interview will not be required in these circumstances. Although we would guarantee a place for September 2022 and waive the requirement to sit the UCAT and interview, the offer would be conditional on achieving our A-level grade requirement as listed below.

<u>For Medicine</u> applicants sitting autumn 2021 exams, the standard AAA requirement will be applied. Choosing to sit the summer 2022 exams would result in our resit grades of A\*A\*A to be applied.

For Dentistry, grades of A\*AA will be applied for both the autumn 2021 and summer 2022 exam periods.



# Sitting exams in a future exam series – Medicine and Dentistry

We will only permit applicants to sit one of these exam periods for an application to be considered. If an applicant fails to meet the required standard in the autumn exam period, the application will be rejected and they will have to reapply for 2023 entry. Standard entry criteria, including UCAT and A-level resit grades would apply.

Due to the cap on student numbers, this guarantee would apply to conditional firm applicants only and not extend to those holding a conditional insurance offer. If students have accepted us as their insurance choice and choose to sit exams in autumn, they should reapply and will be reassessed alongside the other 2022 cycle candidates and would be required to take a new UCAT exam.





### **Applicants and offer holders FAQs**

We understand that the current coronavirus situation remains unsettling and uncertain for many students. We have produced a set of frequently asked questions for applicants and offer holders including information on applications, accommodation, fees and funding and teaching and learning.

# Have you been in care for more than 3 months?

As part of your UCAS application you will be asked to indicate if you have been i to time living in public care as a looked-after-child, including:

- With foster carers under local authority care
- In a residential children's home
- Being looked after at home under a supervision order
- Living with friends or relatives in kinship care

This does not refer to time spent in boarding schools, working in a care or healt you are a carer yourself.

#### Outcome: WP Plus PLUS

Should you submit an application to the University in the 2022 cycle using the information provided, your application would receive a 'WP Plus PLUS Flag'. This means you may receive a contextual offer with a two grade reduction (A-level or equivalent) should you also meet all of the following criteria:

- The qualifications and subjects you are applying with meet our published entry
  requirements. For example, if a course requires Chemistry and Maths you must be taking
  both of these subjects. Some courses may also require specific grades in specific subjects.
- You are applying for a course where the minimum entry requirements are ABB and the course is not a Faculty of Science & Engineering Foundation course.
- Your predicted grades are within two grades of our minimum entry requirements. For
  example, your predicted grades are BBB where the standard entry requirements are AAB.
- You successfully complete any additional selection requirements e.g. interview or aptitude test (eg UCAT for Medicine).

For further information, please see our <u>contextual admissions</u> page. Offers may change or be revoked if we find that information provided as part of the application is incorrect meaning that an applicant does not meet the eligibility criteria. Reductions applied as a result of contextual admissions will not be made lower than BBC at A-level (or equivalent).
