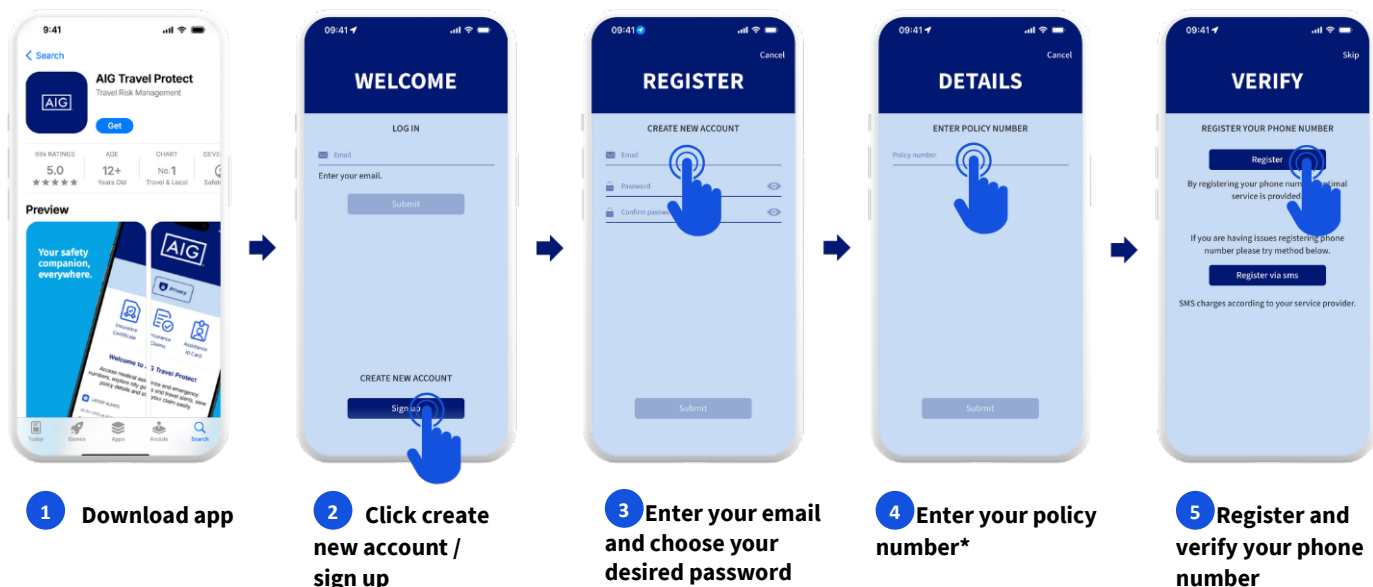

By downloading the app, you gain access to a powerful tool that provides peace of mind, empowers you with real-time safety information, and helps ensure your well-being is never compromised.

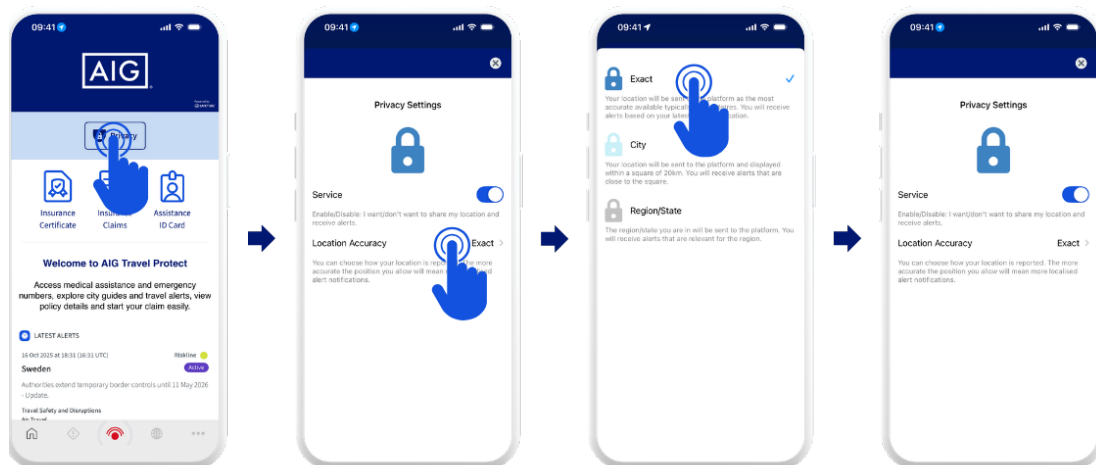


How To Download & Login



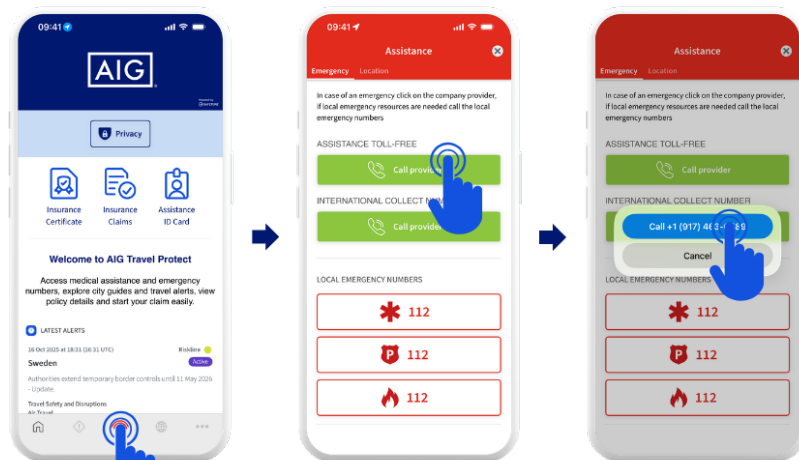
* Policy numbers should start with 00 and be 10 digits long. If your policy number starts with 'LEA', please remove 'LEA' when entering the policy number. The policy number should not contain spaces.

How To Change privacy & update location settings



- 1 From the home screen, push Privacy at the top
- 2 Push Location Accuracy
- 3 Select your desired level
- 4 Keep service ON

How To Initiate Emergency Assistance



- 1 From the home screen, push the Assistance button
- 2 Push one of the assistance buttons
- 3 Push the phone number to initiate a call to assistance

Change Privacy Settings

To change your privacy, go to “Privacy” on the Welcome page in the app. You can set privacy for exact, city, and region/state. Also, make sure to set your phone’s location to “always allow.”

Filter Alerts

You can filter what you see on the map in the app’s alerts tab. You’ll always get relevant push notifications based on your location, regardless of risk.

Battery Usage

The app generally uses about 2% of your battery when in the background during a day.

No Internet Connection

The app works on both wifi and mobile networks. For the fastest experience we recommend using the app on wifi. Critical functions like the emergency assistance button will always be available.

App Languages

The app supports system languages and offers machine translation for more languages. You can change this in the app’s settings.
