Annual Report of Student Appeals, Student Complaints and Student Discipline Cases 2020-211

Section 1: Executive summary

The Annual Report details the number and nature of formal academic appeals, complaints, discipline and fitness to practise cases handled each academic year and is required under the Regulations for the relevant areas.

The overall number of cases across the different Regulations represents a small proportion of the total student population (2.37% in 2020-21 rising from 1.44% in 2019-20).

The academic year 2020-21 has been an extraordinary year due to COVID-19 which resulted in a number of challenges for the whole sector. Early in the academic year, we saw the introduction of the national Tiers system and the legal limitations on the number of people allowed to meet together within prescribed groupings (bubbles). In addition, with a lot of teaching being delivered remotely, our students spent a lot of time in their accommodation. These restrictions resulted in a significant increase in the number of residences disciplinary cases from 313 in 2019-20 to 1404 in 2020-21. We also experienced a significant increase in the number of academic malpractice cases received in Faculties following the move to online assessment. These increased from 120 in 2019-20 to 440 in 2020-21. The significant increase in activity and no additional staffing resource to respond, meant that at times, despite their best efforts, case handlers were unable to meet the prescribed deadlines for providing a response.

In relation to academic appeals after three years of a continual decrease in the number of cases in 2020-21 we saw a marked increase from 262 to 383 but this is still lower than the peak of 409 received in 2017-18. The number of formal complaints also rose significantly from 113 in 2019-20 to 182 in 2020-21.

These rises in case numbers can be attributed to the impact on the student experience of the COVID-19 pandemic and also reflects the position in other institutions.

The number of formal appeals received by Faculties saw a change of distribution in 2020-21. For a number of years the Faculty of Biology, Medicine and Health (BMH) received the highest number of formal appeals at its highest receiving 59% of all appeals. In 2020-21 the Faculty of Science and Engineering (FSE) received the highest number of appeals with 38%. The percentage of appeals received in BMH continued to fall to 33% from 44% in 2019-20.

There has been a significant decrease in the number of students submitting cases to the Office of the Independent Adjudicator (OIA): 38 cases in 2020-21 compared with 104 cases in 2019-20 and 57 in 2018/19. The large increase in 2019-20 was chiefly due to a large number of students (44) attempting to take complaints to the OIA regarding the impact of industrial action and/or COVID-19 without first completing the University's internal procedures. In 2020-21 the OIA found all of the complaints they received about the University of Manchester to be Not Justified. However, of the 13 cases ongoing from 2019-20 they one case to be justified and four others to be Partly Justified.

In response to a number of the issues highlighted in the report, a number of actions should be noted.

- The Conduct and Discipline team have introduced a new 'fast-track' discipline route in part as a response to the large increase in academic malpractice cases.
- An 'Assessment for the Future' project has been established to review the academic malpractice increase and measures that could be adopted University wide to minimise this.
- The Faculty of Biology Medicine and Health have amended the Fitness to Practice Procedures so that can cases can now be referred to both School and Faculty hearings, depending on their severity, with appeals now usually being a document-based review by a panel to prevent this stage of the process being a rehearing of the case.

The largest percentage increase from 2019-20 is in FSE for Conduct & Discipline rising from 0.24% last year to 2.5% this year (as noted in the Executive Summary). This related to the increase in academic misconduct cases following the move to online assessment.



The three cases where decisions were altered resulted in the following outcomes:


- Compensation of £3,250 and a requirement for DASS to work with the School and Doctoral Academy on procedural improvements
- Compensation of £1250 with an option to audit units during semester two
- Compensation of £3,000 for the cancelation of clinics.

The Division of Teaching, Learning and Student Development also reviews complaints against the Students' Union which have been dealt with under the Students' Union Code of Practice. One review requests in relation to such complaints was received during the 2020-21 academic year, of which the original decision was fully upheld.

After the review stage, the University of Manchester procedures are completed and students are issued with a Completion of Procedures letter, as required by the Office of the Independent Adjudicator.

2020-21 saw an increase in the total number of formal appeals received by Faculties after two years of steadily decreasing numbers, which may be in part as a result of the introduction of the Assessment Pledge in response to COVID-19. For a number of years the Faculty of Biology, Medicine and Health (BMH) received the highest number of formal appeals at its highest receiving 59% of all appeals. In 2020-21 the Faculty of Science and Engineering (FSE) received the highest number of appeals with 38%. The percentage of appeals received in BMH continued to fall to 33% from 44% in 2019-20.

In previous years the above data has been reported as White, UK-BME and International students. In 2019-20 we reported that UK BME students made up 17.6% of the student population but constituted 27% of appellants whilst International students make up 39.5% of the student population but constituted 33% of appellants. The comparison for 2020-21 is below.

In 2020-21 all international students regardless of ethnicity made up 29% of the student population but constituted 50.5% of appellants – a significant increase on 2019-20. Whereas the split between UK White and BME students showed no difference in the likelihood to appeal based on population size.

We have previously reported on the difference in appeal outcomes between white and BME home students and International students. The position for 2020-21 continues to show the changes first identified last year. The following table shows the comparator data for 2018-19 to 2020-21.

Appealing against a degree classification or the qualification awarded continues to be the most common single reason for appealing, although the composite category of 'other' contains the largest number of cases overall (this category includes appeals against individual assessment marks for example).

The number of appeals dismissed on the basis that they are invalid, as allowed for by paragraph 5 of Regulation XIX, saw a small increase in 2020-21 to 17% following a steady decrease from a high of 28% in 2017-18. A formal appeal may be dismissed from the outset because it has not been made in time, because it is considered to be a challenge to academic judgement or because it does not meet a pre-condition for an appeal on a particular ground (for example, the Faculty may consider that an appeal made on the ground of mitigating circumstances should be rejected because the student has not offered a credible and compelling reason, with supporting documentation, explaining why they did not utilise the mitigating circumstances procedure prior to receiving their results).

114 out of the 137 upheld appeals (83%) were made on the ground of mitigating circumstances. An upheld appeal does not necessarily mean that the original decision was incorrect but more commonly means that late mitigating circumstances evidence has been provided which may have affected the Exam Board's decision if the evidence had been made available earlier.

Review of Faculty Decision

31 students requested a review of their academic appeal (Regulation XIX, paragraph 10) by the Director of Teaching, Learning and Student Development during the 2020-21 academic year.



There was a decrease in the number of cases that were taken to review stage in 2020-21. The percentage of claims that resulted in the previous decision being altered in some way, reduced from 26% in 2019-20 to 13% in 2020-21. In all four cases, the alteration took the form of a recommendation that Schools were asked to reconsider the case.

After the review stage, the University of Manchester procedures are completed and students are issued with a Completion of Procedures letter, as required by the Office of the Independent Adjudicator.

Section 5: Commentary on Conduct and Discipline of Students (Regulation XVII)

Conduct and Discipline cases may relate to either academic malpractice or non-academic misconduct and are handled in a variety of different locations within the University depending on the nature of the offence, the seriousness of it, the student's previous history etc. Previous Senate Reports have focused primarily on cases handled by Faculties, the University Disciplinary Panel and those handled by a Summary Discipline Panel in relation to exam misconduct. For the purposes of comparison with previous years, figures for these types of cases are given first below, followed by cases handled by other areas of the University. The Student Conduct and Discipline Committee, chaired by the Vice-President for Teaching, Learning and Students, maintains an overview of training for panel chairs, diversity of panel members, and issues arising from cases.

In 2020-21 the number of Faculty cases rose significantly from 120 to 440. The move to online delivery and assessment in response to COVID-19 contributed to the considerable increase in malpractice cases. Whilst plagiarism remains the largest proportion of cases dealt with at Faculty level, the number of collusion cases also rose significantly.

There has also been a significant change across the demographics, where last year white students were the slightly more likely demographic of students to be involved in instances of academic malpractice, in 2020-21 81% of students accused of academic misconduct were BME students.

74% of students whose academic malpractice cases were referred to a Faculty were found guilty, and most of these were either given a mark of zero for the specific piece of work or course unit in which the unfair practice occurred or had their original mark reduced.

University Disciplinary Panel Cases

Cases of academic malpractice or non-academic misconduct deemed to be particularly serious, or where the student has a previous disciplinary record, may be referred to a University Disciplinary Panel. These panels are organised by the Division of Campus Life. The membership of each panel is drawn from a list of colleagues nominated by each Faculty and approved by the Student Conduct and Discipline Committee. Faculties are asked to ensure diversity in the nominations put forward.

Where a student is found guilty by the UDP, penalties tend to be more severe than for cases dealt with at a lower level. Two students were expelled during 2020-21 following a UDP.

Summary Discipline (Exam Misconduct) Cases

When a student is suspected of possessing unauthorised material in a centrally arranged University exam, these cases are usually dealt with by a Summary Disciplinary Panel organised by the Exams Team in the Division of Student Admissions and Administration.

There were no cases reported in 2020-21 as all examinations took place online as a consequence of COVID-19.

Summary Discipline (Non Exam Misconduct) Cases

In 2020-21 a number of Summary Disciplinary Panels were organised by the Division of Campus Life.

Of the 1404 cases 569 (41%) were found not to have breached the regulations following the disciplinary hearing compared with 6% of all hearings in 2019-20. Of those found to be in breach 1 student was expelled from their accommodation compared to none in 2019-20 and 2 in 2018-19.

Fines totalling £70,350 were issued during 2020-21 compared to £23,610 in 2019-20 and £44,365 in 2018-19 – £22,425 of which related to drug related offenses, £19,225 related to smoking or tampering with a fire alarm and £22,500 related to breaching COVID-19 regulations. All fines are reinvested to support student life in our halls or to provide additional hardship funds.

School Cases

Except in severe cases, Schools tend to handle instances of first offence UG and PGT academic malpractice and may also handle some instances of non-academic misconduct. Plagiarism remains the most common type of misconduct that Schools investigate. The TLSD requests data from Schools on the cases heard by them for inclusion in this report. The data collected from Schools is detailed below.⁷

Appeals against conduct and discipline decisions

Of the 84 cases, 34 cases related to appeals against accommodation decisions – of which seven had their original decision altered. 42 cases related to appeals against Summary Disciplinary Committees relating to academic malpractice six of which had their original decision altered. The remaining eight cases relating to appeals against a University Disciplinary Committee one of which had the original decision partly altered.

Where the original decision was altered at appeal stage, five cases were referred back for reconsideration.

After the appeal stage, the University of Manchester procedures are completed and students are issued with a Completion of Procedures letter, as required by the Office of the Independent Adjudicator.

Section 6: Commentary on Fitness to Practise⁸

Fitness to Practise cases originate in the Faculty of Biology, Medicine and Health (BMH) because of the nature of the programmes of study undertaken in that Faculty. Cases can arise for a variety of reasons, which often relate to matters of health and professional conduct. The Fitness to Practise procedure was amended in 2020/21 which allowed for a BMH School Concern Review Panel the power to refer a student to a Fitness to Practise Committee at either School or Faculty level. Details of the School level panels are reported in a separate table below.

Due to the length of time over which a Fitness to Practise case can run, and to reflect a clearer picture of outcomes, the data presented below is based on the number of Fitness to Practise Committee hearings that took place during the 2020-21 academic year.



Appeals against a decision of a Fitness to Practise Committee can be made on the grounds of disproportionate outcome, procedural irregularity and/or the availability of new evidence. During the 2020-21 academic year, one appeal was submitted to the Division of Teaching, Learning and Student Development. The original decision of the Fitness to Practice panel was upheld at review. One appeal was referred to the Faculty of BMH following a School Fitness to Practice Panel. The original decision of the School FtP panel was upheld

After the appeal stage, the University of Manchester procedures are completed and students are issued with a Completion of Procedures letter, as required by the OIA.

Section 7: Commentary on cases taken by students to the Office of the Independent Adjudicator (OIA)



The OIA is appointed as the national independent body to consider student complaints. Usually, a student needs to have completed a University's internal procedures before taking a case to the OIA. The OIA has no regulatory powers over universities and cannot punish or fine them; however, universities are expected to act upon its recommendations. The Division of Teaching, Learning and Student Development acts as the University's point of contact for the OIA.

The number of complaints made by students to the OIA saw a significant fall in 2020-21 from 104 to 39, however we should note that 44 of the cases submitted in 2019-20 were students attempting to take their case to the OIA about industrial action and/or COVID-19 before completing the University's procedures. It does however appear so show a reversal on the steady increase in cases considered by the OIA since 2016-17. The anomaly seen during the 2015-16 academic year can be attributed to the OIA changing its timeframe for complaint submission from 3 months to 12 months.

None of the cases submitted to the OIA during the 2020-21 academic year were found to be either justified or partly justified.

In four of the cases where the University agreed to settle, we made the following offers to students as a result:

- Two students had their £50 fine waived as an apology for the delay in considering their cases
- £1,165 refunded in respect of accommodation charges
- £1,500 compensation for the changes to the student's programme.

One of the outstanding cases from academic year 2019-20 was found to be Justified, with a further four cases found to be Partly Justified.

In the Justified case the OIA made the following recommendations:

- Offer £24,003.84 to compensate for loss of earnings for one year. The OIA concluded that the University's delays in the appeals process ultimately led to the student losing a job opportunity, due to have started in Autumn 2020 (see case summary below)
- Offer £300 for the distress and inconvenience caused by the delay in the appeals process

In the Partly Justified cases the OIA made the following recommendations:

- Offer £714.77 tuition fee refund (returned to SFE) for lost teaching hours due to strike action
- Two offers of £202.35 tuition fee refund (returned to SFE) for lost teaching hours due to strike action
- Offer £244.85 tuition fee refund (returned to SFE) for lost teaching hours due to strike action

The OIA noted that "the time taken to deal with the appeal far exceeded the timescales indicated in the Regulations, and we think that this delay ultimately led to [the student] losing [their] job offer. As such, we believe that the settlement offered by the University to [the student] (£1750) did not adequately take account of the impact of the lost job opportunity, in terms of lost earnings and career progression." The OIA recommended that the University should offer a total sum of £24,303.84, which comprised of £24,003.84 to compensate for the loss of earnings for one year, and £300 for the distress and inconvenience caused by the delay in the appeals process. The student accepted this offer.
