

The Eli and Britt Harari Graphene Enterprise Award 2022



The Masood Entrepreneurship Centre has launched its annual <u>Eli</u> and Britt Harari Graphene Enterprise Award competition, for novel ideas involving graphene and other 2D materials that have the potential to be commercialised.

This prestigious award, in association with Nobel Laureate
Professor Sir Andre Geim, is now open to all students,
postdoctoral researchers, and recent graduates of The University
of Manchester.

Graphene, a two-dimensional carbon material, is a gamechanging UK discovery and its properties make it one of the most important breakthroughs in recent memory. Graphene is a wonder material, with incredible electrical, mechanical, and thermal properties. Prizes of £50,000 and £20,000 will be awarded to the individuals or teams who can best demonstrate how their technology relating to graphene or other 2D materials could be applied to a viable commercial opportunity. This year will also see the inclusion of an additional prize that celebrates the University's position leading the world on sustainable development, more to follow!


University Entrepreneurs Grant 2022

MEC are the official patron of the <u>University Entrepreneurs Grant</u>, a business competition for students at the beginning of their business/entrepreneur journey, that aims to discover a brilliant 'bright idea' that could lead to an amazing new venture.

Entrants simply need to provide a brief outline of their idea and, if shortlisted, they will then have the opportunity to sell their concept to attendees of the Educate North Awards ceremony at the Midland Hotel, Manchester in April. Previous winners have all gone on to attract further investment, run successful businesses and have won further awards.

Last year's winner, Dr. Mohammad El Hajj, from The University of Manchester, went on to win first prize in the technology category of MEC's <u>Venture Further Awards</u> 2021. Mohammad is the Co-Founder and CEO at <u>Bright Biotech</u>, a venture developing a proprietary light-driven, protein expression technology that uses chloroplasts to make extraordinarily high yields of proteins in plants. This game-changing manufacturing system is sustainable, free of animal pathogens and bacterial endotoxins, and highly scalable. Bright Biotech is currently producing recombinant growth factors, which aid cell growth to promote regenerative medicine practices, and also industry processes such as clean meat production, winning a certificate of excellence at the recent <u>EIT Food</u> Demo Day.

QV Bioelectronics Awarded £630,000 Innovate UK Biomedical Catalyst grant

MEC supported start-up <u>QV Bioelectronics</u> have recently been awarded £630,000 of funding under the Innovate UK Biomedical Catalyst Award.

QV Bioelectronics was founded by Christopher Bullock, a Biomedical Engineer who completed his Ph.D. on developing novel graphene biomaterials at The University of Manchester and Clinical Research Fellow Richard Fu. The team were the winners of the Eli and Britt Harari Graphene Enterprise Award in 2018.

The award will help to accelerate the development of the GRACE implant to treat brain tumour patients with electric field therapy. Using advanced materials, the technology underpinning the GRACE device is designed to significantly extend patient life expectancy without negatively affecting the patients' quality of life. This technology could potentially work in conjunction with other treatment modalities to one day turn fatal adult brain cancer into a manageable chronic condition.

The project will allow the company to provide preclinical proof of concept, forming part of a regulatory submission for QV to enter the clinic.

Urbanchain CEO discusses fixing the broken energy market and making energy affordable

Somayeh Taheri, founder and CEO of Manchester based company <u>UrbanChain</u>, was recently interviewed by BusinessLive, discussing the development of the venture in the context of current debates about rapidly rising energy prices and financial pressures on consumers.

UrbanChain, a winner in the 2018 <u>Venture Further</u> competition, is a commercialised peer-to-peer energy exchange, using blockchain and AI to predict the behaviour of renewables, linking it directly to the consumer to reduce the volatility of prices.

Somayeh suggests that it may not be too late to fix the 'broken' energy market and that a key strategy for this would be to decouple renewable energy from the gas market.

Entrepreneurs@Manchester Series: Joseph Foster, Founder of Reebok

We are very pleased to welcome Joseph William Foster, Founder of Reebok!

Joseph William Foster (Joe Foster) was born in 1935 in Bolton England with the same birthday 18 May, as his grandfather, also Joseph William Foster who had died 18 months earlier. Joe's grandfather was the founder of J W Foster & Sons (Athletic Shoes) Ltd. and the inventor of the Spiked Running Shoe and the Trainer (Sneaker).

Joe and his late brother Jeff were born into the J W Foster & Sons family business, but on their return after 2 years away from home on National Service, they asked questions. The year was 1955 and the brothers saw a business still rooted in the 1930's.

Their Father and Uncle were now operating the business and very much like another Sports Shoe company, spent more time feuding than collaborating. The result was that in 1958 Joe and Jeff left the Foster business to set up a new Sports Shoe company.

The brothers founded Mercury Sports Footwear, which after 18 months they changed its name to REEBOK. Joe had been advised to protect their company's name by registering it.

By 1965, Joe was on his way to the NSGA (National Sporting Goods of America) Show in Chicago, which was the start of many Global adventures and experiences that after 15 years brought him together with Paul Fireman and later many Stars of film and television.

As the surviving Founder of Reebok, Joe still welcomes the opportunity to travel and recount those early stories from start-up to taking the company to a \$4 billion business, overtaking Adidas and Nike to become the World's No. 1 sports brand. Joe has written his book Shoemaker to share his story and help inspire the next generation of budding entrepreneurs.

The Royal Academy of Engineering's Enterprise Hub have opened their Enterprise Fellowships programme for a new round of applications.

The Enterprise Fellowship is a 12 month programme that supports innovative, creative entrepreneurial engineers who have demonstrated an exceptional innovation in engineering which they want to develop further.

The programme focuses on equipping the awardee with the confidence, skills, experience and network of expert advisors necessary to enable them to develop their innovation.

The fellowships support researchers wishing to spinout a company from a university, recent graduates wishing to create a

company, and international Ph.D. students based in the UK, wishing to spin out or start up.

The Fellowships provide:

- Up to £60,000 equity-free funding;
- Tailored mentoring and training;
- Access to Academy's networks;
- Lifetime membership of the Academy's Enterprise Hub;
- Access to drop-in workspace in central London,

After the programme, continued support includes continued access to facilities, training programme, PR and media support, network of investors, experts, advisors and Academy Fellows.
