Throughout the course, you will become acquainted with ethical arguments in the context of a range of 'practical' healthcare dilemmas including:



Understanding the role of the law in regulating healthcare practice, identifying and enforcing the rights of patients and in seeking to resolve ethical dilemmas in medicine



Knowing the relevant case-law, statutory materials and their relationship to the ethical debate



Developing an understanding of the main types of arguments used in the research ethics field, and the main areas of controversy



Understanding the relevance of ethics to decision-making in the context of genetics and the applications of genetic science



Examining the effectiveness of mental health law by reference to principles/philosophies from relevant disciplines (psychiatry, psychology, ethics, criminology, social policy)

For the **LLM**, you need to complete five units - including two law-focused options (120 credits) and a law-based dissertation (60 credits). For the **PGDip**, you need to complete five units (120 credits), including two options. To achieve the **PGCert in Ethics**, you need to complete three ethics-focused units (60 credits) and for **PGCert Law**, you need to complete three law-focused units (60 credits).

PHILOSOPHICAL BIOETHICS (30 CREDITS)

- + **Mandatory for: MA, LLM, PGDip, PGCert Ethics**
- + Through this unit, you will develop the skills and knowledge needed to address ethical questions with confidence, and learn how to apply them to a range of healthcare-related issues.

02

MEDICO-LEGAL PROBLEMS (30 CREDITS)

- + **Mandatory for: MA, LLM, PGDip, PGCert Law**
- + Through this unit, you will develop a sound understanding of the role of the law in regulating healthcare practice, identifying and enforcing the rights of patients and in seeking to resolve ethical dilemmas in medicine.

INTERNATIONAL ISSUES IN HEALTHCARE LAW AND ETHICS (30 CREDITS)

- + **Mandatory for: MA, LLM, PGDip**
- + Through this unit, you will develop your understanding of healthcare law and ethics in a global context. It will enable you to critically analyse differing national responses to universal problems in the healthcare context and to consider the factors that contribute to these responses.

RESEARCH ETHICS (15 CREDITS)

- + **Mandatory for PGCert Ethics**
- + **Optional for MA, PGDip**
- + Through this unit, you will gain in-depth knowledge and understanding of the historical development of research ethics - the main international guidelines in this field, and the main arguments specific to topical areas of research ethics.

ETHICS, GENETICS AND GENOMICS (15 CREDITS)

- + **Mandatory for PGCert Ethics**
- + **Optional for MA, PGDip**

- + This unit will present, and encourage you, to engage with key moral debates relating to the development and use of genetic technologies.

MEDICINE, LAW AND SOCIETY (15 CREDITS)

- + **Mandatory for: LLM, PGCert Law**
- + **Optional for MA, PGDip**

- + In this unit, you will study further key topics in healthcare law, such as how the law approaches the medical care of children and adolescents, the law surrounding reproductive technologies and the use of human embryos in research and treatment.

MENTAL HEALTH LAW AND POLICY (15 CREDITS)

- + This unit will introduce a range of philosophies and ideologies that underpin mental health legislation, past and present. Through this unit, you will develop your understanding of law and policy on mental health issues in England and Wales.

PROJECT (60 CREDITS)

- + **Mandatory for MA and LLM**

- + The dissertation project provides an opportunity for those registered on the LLM or MA to explore an area of healthcare law and ethics in more depth. Students registered on the LLM should choose a dissertation topic which is predominantly law-focused, whereas those on the MA can choose to focus on law or ethics or adopt a blended approach.

Medico-legal problems is the core law unit of the programmes. The unit aims to equip students with a sound understanding of the role of law in regulating healthcare practice and addressing common ethical problems that arise.

We cover key topics including consent and informed consent, privacy and confidentiality in healthcare, access to healthcare, human rights law and clinical negligence. On completion of the unit, students will have a solid grounding in healthcare law which can be developed further through the optional law course units in year two.

PHILOSOPHICAL BIOETHICS (30 CREDITS)

ABOUT THIS UNIT

This unit provides a comprehensive introduction to philosophical bioethics, equipping you with the skills and knowledge to address ethical dilemmas in healthcare decision-making confidently.

You will explore foundational moral philosophy, healthcare ethics, and their practical application to contemporary issues. Topics include the moral status of embryos, autonomy and consent, resource allocation, and end-of-life decisions such as assisted dying and euthanasia.

Through engaging course materials and activities, you will critically examine philosophical arguments and develop the ability to present clear, structured reasoning in complex healthcare contexts. The unit is delivered entirely online, offering a flexible learning environment with digital course materials, interactive discussions, and guided activities.

ABOUT THIS UNIT

This unit explores the intersection of law, healthcare practice, and ethics, providing you with a comprehensive understanding of how legal principles regulate healthcare and protect patient rights.

You will examine key areas of healthcare law in England and Wales, including consent and informed consent, the treatment of mentally incapacitated patients, privacy and confidentiality, access to treatment and clinical negligence, alongside broader themes such as human rights and the criminalisation of medicine.

Through engaging with the course materials and activities, you will gain insight into how the law addresses ethical dilemmas in the healthcare and balances competing interests in a complex social context. The unit is delivered entirely online, offering a flexible learning environment with digital course materials, interactive discussions, and guided activities.

ABOUT THIS UNIT

This unit examines healthcare law and ethics from a global perspective, focusing on how different nations address universal healthcare challenges and the factors influencing their responses.

You will explore diverse topics, including public health ethics, cross-border healthcare, biotechnology regulation, and live organ donation.

By analysing case studies and legal frameworks, you will evaluate the effectiveness of international regulations and the extent to which universal ethical codes are feasible.

The unit highlights the intersection of cultural, legal, and ethical considerations in healthcare, encouraging critical reflection and independent research to tackle complex global issues.

RESEARCH ETHICS (15 CREDITS)

ABOUT THIS UNIT

This unit provides an in-depth exploration of research ethics, focusing on its historical evolution, current frameworks, and key controversies.

You will examine the ethical guidelines and principles governing medical and non-medical research, with particular attention to vulnerable participants, controversial studies, and the role of research ethics committees.

Topics include the history of research ethics, the legal and ethical implications of clinical research designs, research in developing countries, and the use of unethical data from historical experiments. By critically engaging with these issues, you will develop analytical skills to independently evaluate complex research ethics problems.



ETHICS, GENETICS AND GENOMICS (15 CREDITS)

ABOUT THIS UNIT

This unit explores the ethical, legal, and societal dimensions of genetics and genomics, equipping you with the conceptual tools needed to analyse and address complex dilemmas in medical and social contexts.

Topics include genetic storage, biobanking, genetic testing, human genetic manipulation, cloning, and synthetic biology.

You will critically examine the existing legal and ethical frameworks governing genetics and genomics and engage with philosophical debates on issues such as genetic enhancement, personalised medicine, and incidental findings.

The unit emphasises the practical application of ethical reasoning to real-world challenges, fostering your ability to construct and present clear, structured arguments.

MENTAL HEALTH LAW AND POLICY (15 CREDITS)

ABOUT THIS UNIT

This unit provides a detailed exploration of the laws and policies governing mental health in England and Wales.

It examines the philosophical and ideological foundations of mental health legislation and the application of these principles to contemporary legal frameworks, including the Mental Health Act (MHA) and Mental Capacity Act (MCA).

Key topics include civil and criminal admissions under the MHA, detention and treatment provisions of the MCA, and the intersections between physical and mental health treatment.

You will critically evaluate the effectiveness of these laws and their alignment with broader disciplines such as psychiatry, psychology, criminology, and ethics.

The unit is composed of the following sections:

1. Introduction to Mental Health Law; Theories of Mental Disorder
2. MHA Civil Admission Part 1
3. MHA Civil Admission Part 2
4. MHA Criminal Admission
5. The MHA and MCA: Treatment for Physical and Mental Ill Health

MEDICINE, LAW AND SOCIETY (15 CREDITS)

ABOUT THIS UNIT

This unit examines the interplay between medicine, law, and societal values, addressing key issues such as the medical care of children and adolescents, reproductive technologies, and the use of human embryos in research and treatment.

You will critically explore how the law regulates controversial areas of healthcare, reflecting on the ethical debates that underpin legal frameworks. Topics include parental responsibility, adolescent autonomy, surrogacy, abortion, and the regulation of reproductive technologies.

The unit also provides an opportunity to consolidate knowledge from previous study, particularly the Medico-Legal Problems course, while further developing your research and analytical skills.

The unit is composed of the following sections:



PROJECT (60 CREDITS)

ABOUT THIS UNIT

The dissertation project provides an opportunity for those registered on the LLM or MA to explore an area of healthcare law and ethics in more depth.

Students registered on the LLM should choose a dissertation topic which is predominantly law-focused, whereas those on the MA can choose to focus on law or ethics or adopt a blended approach.

You will be allocated an academic supervisor who will provide support and guidance during this part of your studies. Your dedicated supervisor will help you to refine your research question and will provide feedback on draft sections of the dissertation.

The dissertation is 10-12,000 words long and is submitted in early September of Year 2.

- + Undertake a significant research based project interrogating an area of healthcare ethics and law
- + Produce a long-form, well researched, and well-argued dissertation that contributes to the knowledge around a chosen subject
- + Design a research question and choose appropriate methodologies

- + Evaluate literature, methodologies, and findings to create a coherent argument
- + Develop writing skills through conveying complex ideas in a structured, precise, and persuasive manner





MA/LLM

You must hold a minimum Upper Second (2.1) class honours degree, or the overseas equivalent, in a relevant subject (eg medicine, law, philosophy, nursing, religious studies)

PGDip

You must hold a minimum Lower Second (2.2) class honours degree, or the overseas equivalent in a relevant subject (eg medicine, law, philosophy, nursing, religious studies).*

PGCert

Postgraduate Certificate (PGCert) applicants must hold a minimum of a Lower Second (2.2) class honours degree.*

*In exceptional circumstances candidates who do not have first degree, but who can demonstrate professional competence, may be admitted.

ENGLISH LANGUAGE REQUIREMENTS

- + IELTS - overall score of 7, including 7 in writing with no further component score below 6.5, or equivalent.



WHAT TO SUBMIT WITH YOUR APPLICATION

When applying for this course you will be required to submit the following:

- + **Copies of official degree certificates and transcripts of your previous study**, showing the subjects taken and grades obtained. If these documents are in languages other than English, please provide official translations in addition to your official certificates and transcripts.
- + **English language score report** (if applicable) or alternative evidence to demonstrate your English language competency.*
 - *If you are not from or did not graduate from a majority English speaking country, we will also require proof of your English language ability. If you have already taken an English language qualification, please include your certificate with your application. We may be willing to consider your application without this document, but if we choose to make you an offer, the conditions will include IELTS (or equivalent qualification).
- + **In some cases, we may ask you to provide your full CV or a personal statement.** We will let you know if these are required once we have reviewed your application.

EMMA'S STORY

Dr Emma Temple decided to pursue an LLM in Healthcare Ethics and Law to deepen her understanding and enhance patient care as a senior intensive care decision-maker.

Dr Temple qualified from the University of Cambridge in 2007 with a Bachelor of Medicine and Surgery. After 14 years of training in the UK and Australia, she completed Postgraduate Fellowships in Anaesthesia (FRCA) and Intensive Care Medicine (FFICM) and became a Consultant Neuro Anaesthetist and Intensivist in 2020.

“Throughout my training, I recognised the critical importance of understanding the legal and ethical principles underlying healthcare. This is particularly vital for those, like me, who care for vulnerable patient groups, such as individuals with brain injuries. In today’s era, where medicine is guided by what we should do rather than what is possible, these principles are key to providing balanced care.

As a full-time NHS Consultant, mother, and partner to a busy surgical doctor, I needed a flexible course that fit my demanding schedule while offering opportunities to engage with faculty and peers. The optional face-to-face days and the course’s balance between ethics and law were particularly beneficial. The department’s support was exceptional, with faculty providing guidance and understanding of the challenges of balancing studies with life’s pressures.

Despite initial apprehension, writing my 12,000-word dissertation became my favourite part of the course. I appreciated the freedom to explore topics related to my career in Neuro Critical Care. The skills I gained in academic writing, literature evaluation, and appraising legal judgments have been invaluable, helping me improve patient care and initiate quality improvement projects within my department.


