Dear UNFCCC secretariat

I don't want to be like every other letter you get, asking why you aren't doing anything and that we need to do xyz.

I understand how many issues you are struggling to solve and how hard it is to create strategies and laws helping these. I know you can see what is inevitably happening to our planet and how worried I hope you are. But what I want this letter to do, is to present the facts that I think we all need reminding of.

To re illiterate my knowing that our world has a lot of issues; I understand your reasoning for why some of them should come before making climate laws, such as banning single use plastic bags, however our future needs to be taken care of. I can't remember a day where I didn't think that when I'm older it's going to be down to my friends and I to fix what people can't be bothered to now.

In 2007-2016, terrorism accounted for 196,529 deaths (0.002% of the whole world population). This is in accordance of the website Statista. Between 2030 and 2050, climate change is expected to cause approximately 250,000 additional deaths per year (estimated by WHO). And terrorism is a very large issue that needs to be treated with extreme seriousness and these almost 200,000 deaths over a ten year period need to be addressed. But putting it into perspective with how dire and extreme anthropogenic global warming is going to be, new and ambitious climate laws need to be passed. In Denmark, a new law was passed saying that if the governing party had not met its climate laws at the end of the year, the would have to step down.
