Section 1: Executive summary

The Annual Report details the number and nature of formal academic appeals, complaints, discipline and fitness to practise cases handled each academic year and is required under the Regulations for the relevant areas.

The past year

The overall number of cases across the different Regulations remains a relatively small proportion of the total student population.

Covid-19 and Industrial Action

- The academic year 2020-21 was an extraordinary year due to COVID-19 and Industrial Action, which resulted in a number of challenges for the whole sector.
- This was reflected in an increase in formal complaints, academic appeals, and conduct and discipline cases (particularly non-academic misconduct in halls of residences, and cases of collusion as exams were conducted remotely).
- During 2021-22, Covid-related complaints have decreased dramatically, as has the number of discipline cases in halls of residences (though this is still significantly higher than the 'pre-Covid' totals).

Formal complaints

- 26% of all Faculty-level complaints were Dignity at Work and Study complaints (i.e. bullying/harassment).
- Other complaints are predominantly related to facilities/services or academic provision/progress.
- Complaints regarding accommodation are submitted directly to Residential Services. In 2021-22 complaints to Residential Services increased from 54 to 70.

Academic Misconduct

- There remains a high case load at school level relating to academic misconduct, with a high proportion of cases involving Chinese and Asian or Asian British students. In instances where action is taken in respect of academic misconduct 33% were Chinese and 24% Asian or Asian British this compares to the % ethnicity across the University of 22.86% Chinese and 12.71% Asian or Asian British. White students made up 45.97% of the University population but only 21% of the academic misconduct cases.
- Whilst plagiarism remains the largest proportion of misconduct cases dealt with at Faculty level, it is notable that collusion cases heard at Faculty level within the Faculty of Science and Engineering constituted 29% of all cases for the year across the whole University.
- Chinese students constituted 26% of all collusion cases, and 36% of all Faculty misconduct cases heard across the University (primarily academic misconduct).

Academic Appeals

- The number of formal academic appeals has risen steadily since 2019-20, from 262 to 383 to 462. In 2021-22 students primarily appealed against 'other decision of the Board of Examiners' (46%), exclusions due to academic failure (31%), and the degree classification awarded (22%).
- FBMH received 44% of all appeals, HUMS 30%, and FSE 22%.
- As in previous years, by far the most common ground of appeal was late mitigating circumstances.
- Of 31% of appeals upheld across the University, 20% of these were upheld in FBMH.
- 49% of all formal appellants were White, 14% Asian or Asian British, and 9% Chinese students. The university ethnic population is 45.97% white, 12.71% Asian or Asian British and 22.86% Chinese students. The ethnic percentage of students appeals matches generally the university population breakdown.

Review requests handled by Teaching and Learning Delivery (TLD) in 2021-22

- 17% of complaint review requests were upheld or partially upheld.
- 23% of academic appeal review requests were upheld or partially upheld.
- 17% of disciplinary outcome appeal requests were upheld or partially upheld.

Complaints reviewed by the Office of the Independent Adjudicator (OIA) in 2021-22

- The number of complaints considered by the OIA rose from 38 in 2020-21 to 51 in 2021-22
- 51% of the complaints were from the Faculty of Humanities
- Only 1 of the cases was found to be justified by the OIA relating to a student from the School of Biological Sciences who complained about the handling of their academic appeal. The University paid £6k to the student in compensation.

Updates and future priorities

In 2020-21, Regulation XIX (Academic Appeals) underwent a full review, with a view to using more accessible English, improve process flows, align with deliverables from the Student Experience Programme, and promote consistency across the University.

- The review engaged colleagues across the organisation.
- Unfortunately, the technology developments required to underpin key changes to the Regulation was delayed resulting in the implementation of the revised Regulation now being September 2023.
- This however does allow more time to introduce the changes to colleagues and provide training/guidance, as well as communicate the changes to students in good time.

In 2022/23 a similar review will be undertaken of Regulation XVIII (Student Complaints).

• This will be carried out alongside a full review of the Dignity at Work and Study (DaWS) 'suite' of policies/procedures.

- A working group has been established to carry out this review, including colleagues from Campus Life and Teaching and Learning Delivery (TLD), as well as EDI and P&OD.
- It is expected that Regulation XVIII will be limited to 'service' complaints, and that the revised DaWS framework will focus on 'people' complaints.
- It is planned that the revised Regulation and framework will be implemented in September 2023.

In 2022, the University's Appeals, Complaints, Conduct, and Discipline Network (ACCD) was opened up to any and all colleagues with an involvement or interest in these areas.

- The network is now co-run by TLD and Campus Life.
- To date 98 colleagues have joined the expanded network.
- A Teams 'hub' serves as a place for collaboration and networking, allowing colleagues to seek peersupport and ask questions. It is also a valuable channel for engagement and consultation.
- ACCD open meetings will be held in 2023.
- An on-campus ACCD Conference will be held in July 2023; this will be an opportunity to introduce upcoming changes, engage with colleagues, etc.

When colleagues signed up for the network, they were asked to rank the **importance** of certain priorities in the area of ACCD and clearly indicated that they are keen to have training materials and digital resources/toolkits for case-handling, and to be engaged with the Teaching and Learning Delivery Team. Cocreation with students is also an important priority.

A note on data

Clean and consistent data is a priority for 2022-23 and beyond; the collation of this report demonstrated how fragmented and inconsistent the University's ACCD data currently is. Over 20 Excel spreadsheets were used in the creation of this report, and much of the data was in need of consolidating or 'cleaning' up/correcting. It would also be useful to log additional data around, for example, DASS-registered students, appeals citing mental health, and more. This will enable us to investigate or act on trends, produce reports more often than annually if needed, respond to FOI requests in a more agile way, etc.



- 1 was referred to a disciplinary panel
- 1 was referred to the University's Intellectual Property procedures
- 1 was offered a £250 compensation payment
- 3 did not specify an outcome

In 2021-22 only 2 cases resulted in compensation at the Faculty stage compared to 10 cases in 2020-21 and 4 in 2019-20.

The total amount of compensation awarded in 2021-22 was £10,958, a significant increase on previous years; this is due to two cases:

- £6,510 awarded Estates and Facilities were slow to attend to a leak in the ceiling despite reports from residents, which resulted in the ceiling collapsing. Nine residents were awarded 6 weeks' rent
- £1,224 awarded for a complaint escalated to Stage 2 in which a senior manager within Residences decided to offer a higher amount of compensation.

Review of Faculty (or equivalent) complaint outcomes by TLD.

Summary of complaint outcome review requests

12 students (compared with 16 in 2020-21) requested a review of their complaints by the Director of Student and Academic Services. Two cases were partially upheld; in one case £1,000 was offered and feedback was given to FBMH about procedure, in the other case an additional £500 compensation was offered.





The number of appeals dismissed on the basis that they are invalid, as allowed for by paragraph 5 of Regulation XIX, saw an increase in 2021-22 to 24%. A formal appeal may be dismissed from the outset because it has not been made in time, because it is considered to be a challenge to academic judgement or because it does not meet a pre-condition for an appeal on a particular ground (for example, the Faculty may consider that an appeal made on the ground of mitigating circumstances should be rejected because the student has not offered a credible and compelling reason, with supporting documentation, explaining why they did not utilise the mitigating circumstances procedure prior to receiving their results).


We continued to see a decrease in the number of cases that were taken to review stage in 2021-22. In the 6 cases where the result involved the previous decision being altered in some way, 4 cases involved recommendations to the School's mitigating circumstances committee, and one case resulted in a student being readmitted to their programme with a new supervisory team.

The one case that was referred to an appeal board resulted in a unanimous dismissal of the appeal by the panel.

After the review stage, the University of Manchester procedures are completed and students are issued with a Completion of Procedures letter as required by the Office of the Independent Adjudicator.

Section 5: Conduct and Discipline of Students (Regulation XVII)

Conduct/discipline cases may relate to either academic malpractice or non-academic misconduct and are handled in a variety of different locations within the University depending on the nature of the offence, the seriousness of it, the student's previous history, etc. The Student Conduct and Discipline Committee, chaired by the Vice-President for Teaching, Learning and Students, maintains an overview of training for panel chairs, diversity of panel members, and issues arising from cases.

School level disciplinary cases.

Except in severe cases, Schools handle instances of first offence UG and PGT academic malpractice and may also handle some instances of non-academic misconduct. Plagiarism remains the most common type of misconduct that Schools investigate. The Teaching and Learning Delivery Team requests data from Schools on the cases heard by them for inclusion in this report.

It should be noted that only 'formal' cases are included in these figures; where a student has received an informal warning, or feedback without the need for the case to proceed to a full hearing, then this has not been captured.







Summary of UDP penalties applied for proven non-academic misconduct cases.









The one appeal upheld in 2021-22 resulted in a recommendation to FBMH that it ensures correct regulator guidance is used in FTP cases, and the student was permitted to graduate.

Section 7: Complaints taken by students to the Office of the Independent Adjudicator (OIA)

The OIA is appointed as the national independent body to consider student complaints. Usually, a student needs to have completed a University's internal procedures before taking a case to the OIA. The OIA has no regulatory powers over universities and cannot punish or fine them; however, universities are expected to act upon its recommendations.

Teaching and Learning Delivery acts as the University's point of contact for the OIA. The number of complaints made by students to the OIA saw a rise from 38 in 2020-21 to 51 in 2021-22.

Only one of the 51 of the cases submitted to the OIA during the 2020-21 academic year was found to be justified. In this case:

- A student from the School of Biological Sciences in FBMH complained about the handling of their academic appeal.
- The OIA considered that the University provided an appropriate academic remedy, but that the University's financial offer for distress and inconvenience did not go far enough to provide the student with an overall reasonable remedy, in view of the particular circumstances.
- The OIA recommended increasing the compensation offer from £3k to £6k.

In the three cases where the University agreed to settle, we made the following offers to students as a result:

- A student from the School of Engineering in FSE complained about the handling of their academic appeal. The University made an offer for a further opportunity to complete first attempts of missed exams, which the student accepted.
- A student from the School of Medical Sciences in FBMH complained about the handling of their academic appeal. The University offered to refer the case to an appeal panel, which the student accepted. The appeal panel upheld the appeal and allowed the student a further opportunity to satisfy the requirements for continuation on the programme or element of the programme (strongly encouraging registration with DASS).
- A student from the School of Medical Sciences in FBMH complained about the handling of their complaint. The University agreed to increase the offer of compensation to £550 from £50.

There were 15 cases classified as 'ongoing' at the time of the 2020/21 annual report. Of these,

- 10 cases were found 'Not Justified'.
- One case is still ongoing (assigned to an OIA case-handler in July 2022).
- The University agreed to settle in two cases;

- o In one case, a FSE student's case was heard by an appeal panel which agreed to offer further opportunities for study, as well as financial compensation of £4,500 for distress and inconvenience,
- o In another case, the University offered to hear a student's case at review stage. The case was considered and dismissed.
- One case was found to be 'Justified' by the OIA, which recommended the University offer an apology and consideration of the student's complaint. Both were offered to the student, who did not respond.
- One cased was found to be 'Partly Justified' by the OIA, which said that the University's decision to uphold the student's complaint was reasonable, but that not enough had been offered by way of resolution. The OIA recommended an offer of £5,000 in compensation, and a review of complaint-handling procedures (particularly in relation to the sharing of information). Note that this will be picked up as part of the 'Dignity at Work and Study' review mentioned in the summary of this report, above.






