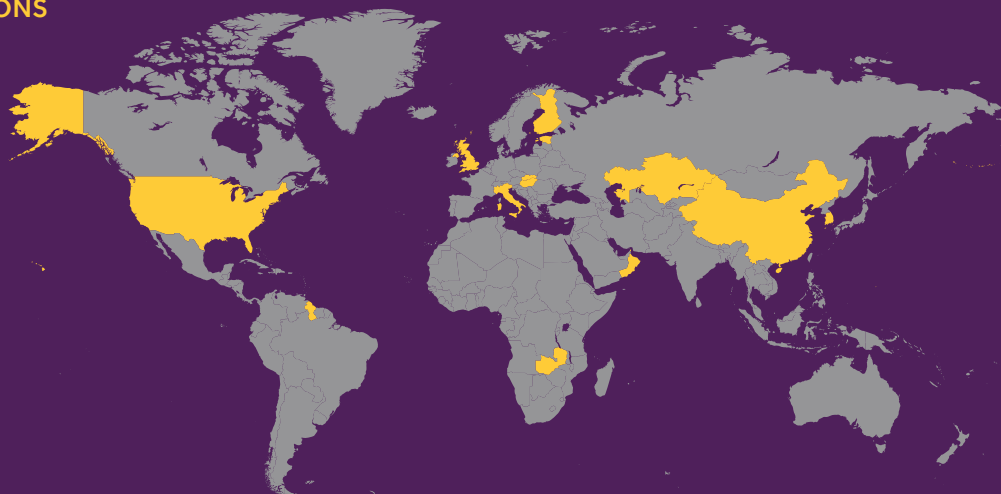

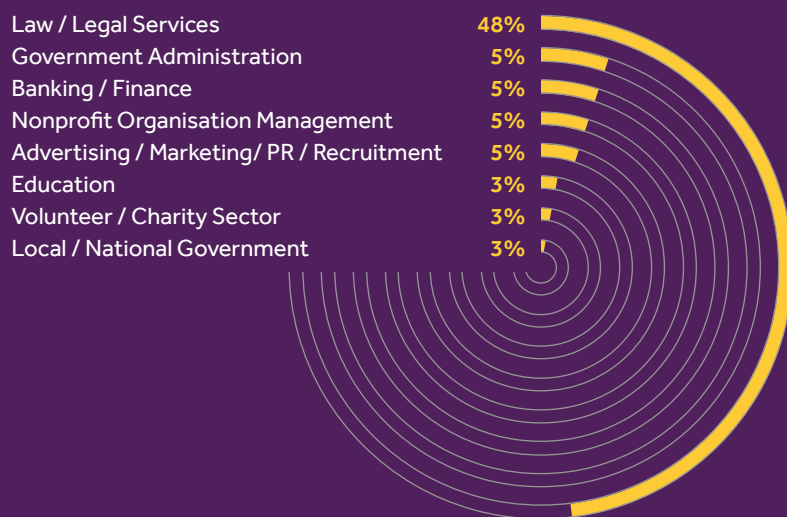

### INTERVIEW

#### *Hi Klaudija! Tell us a bit about why you decided to study Security and International Law at Manchester?*

While there were other universities that offered similar courses, most of them were only for students who graduated Bachelor of Laws (LLB). This was not the case for me as my undergraduate was a BSc in Criminology. I believe this is a great benefit that The University of Manchester has to offer to students and it opens the door for people who share a passion in this field but do not have a legal background.

#### *How did your postgraduate degree help influence your career path?*

My experience at the UoM helped me to refine and clearly understand the more defined areas that I am interested in, not only through the course and modules themselves but also through opportunities to gain practical experience. In particular, the Manchester International Law Center partnered with Global Legal Action Network (GLAN)

to allow students to enrol in a clinical 'international law in practice' project, giving me the opportunity to work on a project that I was deeply interested in.

#### *And how did your course help set you up for your chosen career?*

Throughout the course I gained strong research and project writing skills; learned to think outside the box and consider multiple factors that might affect certain issues that I was analysing; improved my attention to detail as well as time management skills.

Secondly, the course's lecturers were highly knowledgeable and experienced, and were able to provide students with useful practical insights for future careers. I found some of their advice particularly helpful in making some of the decisions for my career later on.

Lastly, I really enjoyed that most of the modules allowed students the freedom to choose their own assignment topics.

This allows students to deep dive into the topics that they are truly interested in, or alternatively to understand what they're not interested in, which is equally important.

#### *What advice would you give to a student looking to start your course and/or join the University?*

My advice would be to try to absorb everything that this course has to offer! Do not be afraid to dive into topics that are not widely discussed (yet); if you have a chance, join some projects that might help you understand your passions. Be open to experiences – join the socials, go to job fairs, don't be afraid to ask. And remember – if you feel that you are stuck – you are not alone, the highly competent staff will be there to support you!
