Application Criteria

Essential:

- Strong interest in gender inequality
- Understanding of real-world data (surveys, census or equivalent)
- Experience in data analysis with quantitative data
- Excellent independent worker with strong organisational skills
- Excellent communication skills

Desirable:

- Interest in data visualisation
- Interest in report writing for a charity organisation
- Knowledge of the ten Greater Manchester boroughs

Project Outline

The data fellow will spend 8 weeks in the summer of 2023 (July and August), undertaking a data-driven research project that would be designed and supervised by GM4Women2028.

The key aims of the fellowship is to produce a report mapping the activities of the 10 Local Authorities of Greater Manchester that are relevant to gender equality across GM4Women's five thematic areas: Employment, Education, Safety, Political Participation, and Culture and Active Lives.

The data fellow will undertake a scoping exercise to identify where data exists in each of the ten boroughs that map to the five thematic areas and ten indicators used by GM4Women2028. The successful applicants will create a report communicating how the ten authorities are using data to deliver better outcomes for Women and Girls in their borough, aligning the data with the strategy of the borough and with the Greater Manchester Strategy.

This report will be instrumental in connecting the gender equality strategies, activities and outcomes across the ten boroughs so we can understand how GM4Women's themes and indicators align with the boroughs and the GM-wide strategy.

Practical Considerations

The internship will last for 8 weeks from the start of July to the end of August. The intern will be employed by the University of Manchester on the living wage. They will be part of the 2023 Q-Step Data Fellows cohort.

Core office hours are expected to be 9 am - 5 pm although we are happy to accommodate flexible working.

As GM4Women2028 do not have office space the student will be expected to work remotely/from home, but this MUST NOT be outside the UK.
