### **POLICY UPDATES**

Policy on Recording and Monitoring Student Attendance and Engagement

The Policy has been updated to include:

- Insertion of a section which sets clear expectations for the attendance levels of student visa holders which will trigger escalation activities, and a high-level summary of the impact of continued non-engagement, in line with requirements from UKVI.
- Insertion of a paragraph within an existing section to refer visa related queries to the Student Immigration Team.
- Insertion of additional sentence to clarify the interaction between this policy and Regulation XX.
- Removal of reference to Blackboard as a specific virtual learning environment.

The UK Visa and Immigration Agency (UKVI) requires that sponsors under the Student route (formerly known as Tier 4) must have a single academic engagement policy in place that applies consistently to all sponsored students including postgraduate researchers (PGRs) with a Student or Tier 4 visa, whether degree seeking or visiting students. These policy amendments are designed to satisfy this requirement from UKVI. These updates are a result of significant engagement with both PS and academic colleagues from across the University, to ensure the applicability of the policy to all students.

# APPEALS, COMPLAINTS AND ACADEMIC MALPRACTICE (REVIEW)

Appeals, Complaints, Conduct and discipline (ACCD) Network Conference: Wednesday 26<sup>th</sup> July 2023 The ACCD is a network for any colleagues (PS or academic) involved in formal or informal academic appeals and complaints, and academic or non-academic conduct and discipline issues.

The ACCD Summer Conference will be jointly hosted by the Teaching and Learning Delivery team, the Advice and Response, and Conduct and Discipline teams within Campus Life. It is being held on Wednesday, 26 July 2023 in the Engineering Building from 9.30am – 3.30pm.

The conference is open to all colleagues and will include:

- Presentations, with introductions and updates from TLD and Campus Life, and the SU Advice Centre.
- Lunch and networking.
- A choice of breakout/workshop sessions in the afternoon most relevant to your role (details TBC).

#### **OIA Annual Statement**

Each year, the Officer of the Independent Adjudicator (OIA - the ombudsman for higher education) publishes information about its members' records in handling complaints and appeals for the preceding calendar year. The OIA has recently published the University of Manchester's statement for 2022. You can read the full statement online here.

#### Some headlines from the statement are:

- UoM issued 365 Completion of Procedures letters, compared to a median of 112.5 for comparably sized institutions. (A CoP letter represents the end of internal proceedings and gives students information on how to make a complaint to the OIA.)
- In 2022, the OIA received 59 complaints about UoM, compared to a median of 37 for comparably sized institutions. This represented 2% of all the complaints the OIA received in 2022.
- The OIA closed 56 of those cases in 2022, and its decisions were as follows:
  - o 2 cases were justified or partially justified (3.4%)
  - o In 5 cases, we offered to settle (8.5%)
  - o 11 cases were not eligible for consideration (18.6%)
  - o 8 cases were withdrawn (13.6%)
  - 30 cases were found to be not justified (51%)
- The complaints about UoM were comparable with the volume received by category across all
  institutions in 2022.
  - 43% of the complaints about UoM related to service issues.
  - o 36% of the complaints about UoM related to academic appeals.
- The University was thanked for its positive engagement with the OIA's webinars and outreach events.
