<p><b>March 2026:</b> Following confirmation from TLD on 11<sup>th</sup> September of the implementation of the <a href="#">updated programme suspension/withdrawal process</a>, the deadline to submit a programme suspension/to the Faculty (with a last intake date of September 2025) will be the last working day in March (31 March 2026). Your Faculty Teaching and Learning Officer (EDPPP) will advise you if the withdrawal/suspension can be considered for Faculty approval via Chair's action. However, if it is determined that the proposal should be tabled at a Faculty QSDE meeting the date for submission will be earlier. This would be agreed with your Faculty Teaching and Learning Officer (EDPPP) in advance.</p>	
<p><b>May 2026 QSDE Meeting:</b> Final meeting at which approval of PGT amendments for implementation from September 2026 / the 2026-27 academic year will be considered. Please note the corresponding paperwork submission deadline is Tuesday 05 May 2026.</p>
