GM Policy Hub seminar: Al and Transport



Experts agree that automated driving technologies constitute perhaps the most significant transformation in urban and transport planning since the invention of the private motor vehicle. All applications in the transport sector could help unlock opportunities that are crucial to GM's long-term growth and prosperity, and contribute to achieving carbon neutrality. However, All applications are not without challenges.

As automated driving technologies are introduced gradually into cities, urban planning has a critical role to play in anticipating the implications of this transition and mediating unwanted consequences for societies. Policymakers must recognise and provide opportunities for diverse viewpoints in envisioning and creating desired mobility futures. Crucially – uncertainty cannot lead to inaction. Transport and mobility policies and plans must address local needs and strategic imperatives. Engagement and constructive dialogue are key.

GM MPs visit University of Manchester campus



Over the last few months, Policy@Manchester has welcomed three MPs representing Greater Manchester constituencies to The University of Manchester. In October, we welcomed Afzal Khan, MP for Gorton; in December, Chris Green, MP for Bolton West; and this month, Mike Kane, MP for Wythenshawe and Sale East.

Manchester Gorton MP Afzal Khan MP visited The University of Manchester to meet academics from our <u>Power in Place</u> publication. During his visit, he also toured the Sustainable Materials Innovation Hub at Henry Royce Institute, the UK's National Centre for research and innovation of advanced materials.

Of the visit, Afzal Khan said:

"It is always a delight to visit The University of Manchester. The evidence-based research it produces across so many subject areas is greatly valued and has real influence on policymakers in Westminster, Whitehall and beyond.

"Power in Place is another thoroughly impressive piece of work and it was helpful to discuss some of its key recommendations with academic staff."

Bolton West MP Chris Green recently visited The University of Manchester to meet with academics from Dalton Nuclear Institute, who work closely with the nuclear industry to highlight the steps needed to develop a policy framework which can secure a long-term nuclear future. He was also given a tour of the Bioprinting Technology Platform which is contributing to progress being made in personalised and regenerative medicine.

Chris Green said:

"It was a fascinating morning. The University of Manchester has a thoroughly merited global reputation for research excellence across a vast swathe of subject areas, not least in technology, innovation and health."

Mike Kane MP, Shadow Aviation and Maritime Minister and Wythenshawe and Sale East MP, visited The University of Manchester to meet academics leading research on the urgent need to reduce shipping emissions. He also toured the ID Manchester site - a £1.7bn tech and science location set to create over 10,000 jobs. Professor Alice Larkin and Dr Simon Bullock, researchers at the University's Tyndall

Centre for Climate Change Research, briefed the shadow minister on achieving Paris Agreement climate goals, specifically on requiring 34% shipping emission cuts.

Of the visit, Mike Kane commented:

"As a Manchester MP, I take great pride in the quality of research and teaching happening here. The work on shipping emissions, led by Professor Larkin and Dr Bullock, is of especially high quality and it was useful for me to drill down into their findings in my meeting with them."
