These awards cover a significant portion of the <u>translational research pathway</u> and are the natural follow-on funding schemes from our internal translational pump priming schemes such as the MRC Impact accelerator Account (IAA) and the Translational Partnership Award Schemes (A2E, C4T) managed by Translation Manchester.
