You must submit your online application for a place on your chosen Postgraduate Research programme by 13 January 2025. This is to ensure you hold an offer of a place by the time the school committee make their selection.

Section 9 of the application asks for your funding intentions. In this section, you should detail fully all the competitions in which you would like to be considered. There is no limit to the number of competitions you may enter, but all must be detailed in your online application form to ensure you are included. Please add a funding source, and populate the fields as below:

- Status of Funding: Intend to Apply

Please note that there is no separate funding application form for the Art History Postgraduate Research Bursary. All decisions are based on the online programme application and supporting documents.





Drama at Manchester has a worldwide reputation for quality. Our teaching is informed by recent innovations in theatre, performance, screen and film studies, as well as by historical practices. #### **Programme Structures**

#### <u>Drama PhD (includes film)</u>

We aim to:

- Our PhD Drama programme enables you to carry out an in-depth piece of research before either writing a full 80,000-word thesis or completing a practice-based dissertation.
- Drama at Manchester offers three main strands of research: Theatre Studies, Applied
  Theatre and Film Studies, including television, new media, and aspects of socially
  engaged film practice.
- All staff are research active within our three main research strands. These areas
  interlink, and both staff and students are keen to cross the boundaries from one area of
  research to another.
- The notion of 'dialogue' with ideas, practices, communities is at the heart of all our practical and intellectual explorations.
- We regularly initiate research-council-funded projects, present seminar series and host conferences.

#### Anthropology, Media and Performance PhD

We aim to:

- introduce you to potential interdisciplinary combinations of anthropology, applied theatre/performance studies and media production so you can produce original knowledge in one or more of these academic fields;
- introduce cutting-edge theories and self-reflexive, critical research practice in all these fields;
- train you in a range of practical field research methods and media production skills to
  enable you to carry out the year-long fieldwork that is an integral and necessary aspect
  of the second year of the programme. These skills will also allow you to produce a
  combination of written dissertation and media and/or performance practice;
- make you aware of the legal and ethical implications of your work and of the appropriate procedures for ensuring ethical clearance of your research;

 encourage you to develop a range of transferable skills. This includes areas such as IT and AV media, as well as presentational, writing, team-working and foreign language skills.

#### Art and Social Practice PhD

Designed for people who want to undertake advanced research which builds on their professional knowledge and practice. Professional practice may include:

- applied practice,
- arts and health,
- community arts,
- performing arts,
- other related contexts across visual and creative media

- Master's degree in a relevant subject with an overall average of 65% or above, a minimum mark of 65% in your dissertation and no mark below 55% (or overseas equivalent)

## **Applications**

- Entrance requirements
  - At least a strong 2.1 in undergraduate degree or equivalent
  - At least 65% average in relevant Master's degree
  - Musicology applicants need at least 65% in dissertation
  - Composition applicants need to provide sample works
- Bursaries and Scholarships
  - Strong record of success in AHRC competition
  - Other students awarded full university scholarships
     (Presidential Doctoral Scholarships and School awards)
  - Music applicants also eligible for specific cohort awards
  - Full (Home) fees bursaries awarded by department (normally two per year)
