New and Updated Policies

The new Policy on Recording and Monitoring Attendance and Engagement is now available to view.

The policy provides clarity in relation to the University's expectations in monitoring attendance and engagement, to ensure that the University proactively monitors student wellbeing, supports academic performance and meets external body reporting requirements, in relation to Undergraduate, Taught Postgraduate and Postgraduate Research students.

Semester 1 Course Unit Surveys

Starting **Monday**, **November 18th**, Semester 1 course unit surveys will be available for students to complete until Friday, December 13th. Students will receive reminders via email to provide feedback on their courses throughout the live period. Emails from the system will cease automatically once all surveys are completed.

This semester, surveys will be accessed using Single Sign-On (SSO). In addition to email links to students, generic links and QR codes will be distributed to schools for promotional use. Academics can find unit-specific links and QR codes in the subject management view, with access instructions to be sent via email once surveys launch.

If students encounter issues accessing their surveys, they should contact <u>teachingandlearningsurveys@manchester.ac.uk</u>. The most likely issue can be resolved very quickly once the team is aware. Staff and school queries are also welcome at the same email address.

Programme Developments 2025/26

DEADLINE REMINDER

This is to remind all Teaching, Learning and Student Experience (TLSE) colleagues that the deadlines for submission of <u>programme development</u> requests to Teaching and Learning Delivery (TLD) for 2025/26 are:

- UG 31 March 2025
- PGT 30 May 2025



Please ensure that you make yourself aware of School and Faculty deadlines for submission and approval of proposals as these deadlines may be considerably earlier than the final date of submission to TLD.

This year we have experienced a substantial increase in late requests which has severely impacted our ability to meet our regulatory obligations in relation to timely production of course marketing information and the Competitions and Marketing Authority (CMA) requirement to provide 'durable' programme information to all offer holders. Therefore, any requests received after the submission deadline will only be considered in **exceptional circumstances** and with the full support of your Faculty Vice Dean for Teaching, Learning and Students.

SCHEDULING (TIMETABLING, EXAMINATIONS AND PROGRSSION & ASSESSMENT)

Timetabling

After some busy months preparing and allocating students to their timetables, the schools and Faculty Scheduling Teams are reviewing aspects that went well and what could be improved in the cycle. Teams should also now be looking toward semester 2 student allocations and processing any required timetable changes.

The timeline for the 2025 – 26 scheduling cycle will be published in December, with timetable data capture opening from January 2025.

A minor update to Resource Booker has also been applied recently, which now allows users to change the room for a booking, rather than having to cancel the booking then make it again.



Exams

The team are collating and processing the exams data returned by schools, to ensure all the correct students and units for semester 1 assessments, and their requirements, are ready to be scheduled.

Scheduling will take place over the next couple of weeks with the composite timetable (without venues) released at the beginning of December.

The invigilation pool has also been strengthened by some new recruits who are keen, ready and willing. Training will take place throughout December and January.

ITL Fellowships

ITL Fellowships provide you with the time, focus and support to work on a teaching and learning project which will lead to a lasting change that improves student experience or outcomes (directly or indirectly) across the university.

The revised ITL Fellowships will be appointed on a 0.4 FTE for a two-year secondment to work on a teaching and learning project in one of the University's priority areas. Three priority areas have been identified:

• Community-engaged learning: education that has mutual benefit with the community (also referred to as service learning).

• The teaching-research nexus: how our research can inform our teaching, and our teaching can inform our research.

• Curriculum interventions for student success: what can we do to address differential attainment and completion?

This opportunity is open to all staff, including academic, Professional Services and Technical Services colleagues. Joint Fellowships (e.g. 0.4FTE shared by two colleagues) will also be considered.
