1. Welcome and Apologies for Absence

Apologies received: Rory Stanton, George Wolff, Caitlin Owen, Mayowa Olayoriju.

KT: Introduced themselves as the new Associate Director for Academic Advising and Student Wellbeing. The purpose of the meeting is to have oversight of issues that go beyond programmes.

2. Minutes/Actions of the last meeting

KT: Summarised progress on actions from the previous meeting:

- Fault reporting link added to SEED Students Community Page.
- 'You Said, We Did' slides circulated to Reps.

- Work ongoing regarding appropriate use of Mentimeter.
- Ensured this meeting does not clash with Faculty Forum.
- Work ongoing regarding deadline concerns.
 - NB: deadlines are at departments' discretion. Action 1: NB to raise ongoing issue of a deadline in the holidays for 'Climate Change: Science and Society' raised by Reps to Geography department.
 - Reps: Raised related issue: deadline bunching. KT: regulations only require that deadlines are not on the same day. Action 2: RC to investigate best practise on deadline bunching.

3. Rep Consultation

Rep recruitment and training

KT: summarised that Padlet feedback was positive, praising online training.

Welcome week

KT: noted there was extensive work on a prolonged Welcome programme. Summarised Padlet feedback:

- Unit selection confusing.
- Registration process convoluted. Action 3: RC will feedback issues with registration and setting up School email as part of ongoing work.
- Would like more interactive events and social events for returning students.
- There are too many comms channels.

Rep: would like more events on university-expectations for those who are first in family to go to University.

Rep: event advertisement needs to clearly state the benefits of attendance beyond making friends. Would like programme-level events to be condensed. Suggested surveying students during Welcome.

Rep: suggested current students should set up alternative comms channels to target more students pre-Welcome. RC and JS: Reps can communicate via channels of their choosing, but it is not appropriate for staff to prescribe this. RC: noted that pre-arrival, email is the predominant comms channel; use of agents can inhibit receipt.

Comms from the School

KT: summarised Padlet feedback:

- Most prefer email and targeted updates.
- Reps use group chats to reiterate communications.
- Some students ignore School social media.

Rep: SEED Instagram should be advertised in programme level sessions.

Rep: would like conferences to be better advertised for different subjects; JS: offered Hub support.

Student Support outside of programme

KT: summarised Padlet feedback:

- Would like more Careers Sessions.
- There have been difficulties finding placements; noted this may need to be addressed at programme committees.
- Proactive academic advisors are appreciated; could look at making comms on how to access advisors clearer.
- Better advertisement of services needed.
- Counselling and disability support is slow.

Rep: benefits of the Careers Service need to be made clearer to UGs. SP: requested Reps to ask programme directors for Career drop-ins.

Rep: staff should be willing to help students who are not their advisees. KT: support provisions are being addressed at School Board.

Rep: there is a lack of information regarding novel career paths. SP: encouraged specific feedback on programme career pages.

Rep: concerned some academics do not respond to emails. KT: reassured Reps workload is discussed each year; encouraged Reps to contact her regarding persistent issues.

Rep: not all students know who their advisors is.

Rep: unsure how their specific unit supports career development. KT: encouraged raising this at programme committee.

Rep: students are unsure where to find mental health support. KT: signposted to SEED Students Community Page, will periodically circulate lecture shout outs on support. JS: the Hub present in lectures on support during Welcome (could circulate this information to Reps periodically), there are also always wellbeing staff in the Hub.

KT: will reshare How to Get Involved slides.

Teaching

KT summarised Padlet feedback:

- Programmes are well-structured.
- Technology is useful for low-pressure interactions.
- Number of apps required should be consolidated.
- Need more time to ask teachers questions at the end.
- Formative assessments and exemplar assignments are useful.

Action 3: KT: will circulate best practise shared by Rep of lecturer using Padlet throughout the session to respond to questions.

Action 4: KT: will feedback to T&L Committee that students would like rubrics available for each assignment.

4. Any other business

JS: responded to Reps that the SEED Hub cannot exclusively be used by SEED students; it is a library owned space. Could do more comms on alternative study spaces.

KT: Padlet open until the end of the week for additional comments.

Rep (BSc Planning and Real Estate): Concern that, as many third-year units are shared with PGTs, pursing PGT within the department would be a repetition.
