# Overview

Hosted by the **Manchester China Institute at The University of Manchester**, this seven-day training programme is acclaimed as an “intellectual accelerator” leading to the highest echelons of international arbitration. This programme leverages the top-tier academic resources of The University of Manchester and assembles a “master-class faculty” consisting of **former judges of the UK Court of Appeal; the London Commercial Court; the Court of Justice of the European Union**; and the High Court of South Africa; International judges of the Singapore International Commercial Court, **King’s Counsel (KC)**, barristers and international arbitration partners of leading law firms.

The course is tailor-made for **law school students, law firm partners, arbitration institution staff, general counsel of multinational corporations, and arbitrators**. We adopt a unique perspective to deeply deconstruct the core differences and application logic of common law in cross-border transactions. From arbitration process management to the execution of state immunity, we provide comprehensive coverage of dual-track practices in both **International Commercial Arbitration (ICA)** and **Investment Treaty Arbitration (ITA)**.

## Global International Arbitration and Cross-Border Dispute Resolution

Learn from a “dream team” in the global arbitration sector and master the legal wisdom that defines foreign-related rule of law. The course covers the core content of international arbitration, including:

- **International Commercial Arbitration (ICA):** Participants will not only gain an in-depth understanding of the theoretical knowledge and the latest frontier cases of international commercial arbitration but will also focus practically on the arbitration process, the role and selection of arbitrators, arbitration agreements, procedural rules, and the making and enforcement of arbitral awards. **Top-band arbitrators** who have heard cases of international impact will personally review these processes. You will learn how to conduct hearing room management in complex multi-party arbitrations, how to influence the direction of a case through strategic arbitrator selection, and how to utilize emergency arbitrator procedures to freeze opposing assets.
- **Investment Treaty Arbitration (ITA):** Key contents include the jurisdictional features of ITA, substantive protections for investors, and the enforcement of awards against states. By dissecting the latest cases, you will gain insight into the political economy behind the Investor-State Dispute Settlement (ISDS) mechanism and understand why global powers are reshaping this system. We will analyse the delicate balance between the “Right to Regulate” and investor protection, and project the future evolutionary trajectory of ITA through cases involving the latest generation of FTAs (such as CPTPP and USMCA).
- **Legal Foundations:** In cross-border disputes, the application of substantive law often determines success or failure. We will take you **inside the adjudicative mindset of UK courts**, allowing you to intuitively experience the cognitive differences between civil law and common law systems. We will go beyond traditional “connecting factor” instruction, with battle-tested **international law firm partners** guiding you on how to conduct “jurisdictional planning”.

## Programme Structure

Lectures, interactive workshops, and practical exercises are scheduled every morning and afternoon. Topics include arbitration agreements and processes; jurisdiction and substantive treatment in investment arbitration; post-award procedures, including challenges and enforcement; practical arbitration skills, including mock hearings and group exercises. Participants will receive curated reading materials and case studies, fostering a hands-on learning environment.

## Certification and Networking

Upon completion of the training, participants will receive a certificate of attendance. The programme will also offer valuable networking opportunities, including social events, a gala dinner, and a football club tour, allowing participants to build connections with global peers and experts.

# Presenters Biography

## **Professor Orkun Akseli**

Professor of Commercial Law at the University of Manchester School of Law

Professor Orkun Akseli is a Professor of Commercial Law at the University of Manchester School of Law, where his research primarily focuses on the harmonization and modernization of secured transactions laws, development finance, and the facilitation of credit. He possesses a highly international academic background, having earned his LLB and MA in Turkey, an LLM in the United States, and a PhD from the University of Manchester. Prior to embarking on his academic career, he practiced commercial litigation and insurance defense in Izmir, and he currently remains a member of the Turkish Bar. He is extensively involved in prominent national and international law reform initiatives, frequently contributing to the work of global formulating organizations such as UNCITRAL. In addition to his research and law reform activities, he holds significant leadership roles within the academic community, including serving as the current Secretary General of the International Academy of Commercial and Consumer Law.

## **Dr Georgia Antonopoulou**

Lecturer in Commercial Dispute Resolution at the University of Birmingham

Dr Georgia Antonopoulou is a Lecturer in Commercial Dispute Resolution at the University of Birmingham. Her research focuses on international commercial courts in Europe and Asia, the role of foreign judges in domestic courts and international commercial arbitration. It has been published in both specialist and generalist journals, such as the Journal of International Dispute Settlement and the Oxford Journal of Legal Studies. She is currently working on her first monograph on international commercial courts to be published with Cambridge University Press. Georgia's research has been funded by the British Academy, the Socio-Legal Scholars Association and the University of Birmingham-University of Leiden Strategic Collaboration Fund. She has previously held visiting fellow positions at the Max Planck Institute on Procedural Law in Luxembourg, the Singapore Management University, the China University of Political Science and Law, and the University of Macau.

## **Dr Nicolette Butler**

Senior Lecturer in Law at the University of Manchester

Dr Nicolette Butler is a Senior Lecturer in Law at the University of Manchester, specializing in international economic law with a particular focus on global trade and investment policy. Her extensive research footprint covers international dispute settlement, digital trade, and the complex trade-environment nexus, bridging the gap between theoretical frameworks and practical policy applications. Beyond her academic teaching, she has actively engaged in policy-facing work, having previously held a position within the UK Department for Business and Trade. She has consistently served as Principal Investigator on numerous funded projects and has widely disseminated her findings in leading academic publications, including the Journal of International Economic Law and the Journal of World Investment and Trade. Furthermore, her international academic presence is highlighted by prestigious visiting positions she has held at the British Institute of International and Comparative Law in London and Chulalongkorn University in Thailand.

## **Professor Lei Chen**

Chair of Comparative Law, Lee Kai Hung Chair of Chinese Politics, and Director of the Manchester China Institute

Professor Lei Chen is the Chair of Comparative Law, Lee Kai Hung Chair of Chinese Politics, and Director of the Manchester China Institute. His academic research sits at the intersection of comparative private law and transnational dispute resolution, notably leading a landmark multi-volume project to produce the first article-by-article English-language commentary on the Chinese Civil Code. In addition to his scholarly work, Professor Chen is a seasoned international arbitrator and specialist mediator who serves on the panels of leading global dispute resolution institutions, including HKIAC, SIAC, LCIA, and the ICC. His exceptional practical expertise recently led to his appointment to the International Commercial Expert Committee of the Supreme People's Court of China in 2024. Furthermore, his distinguished contributions to legal scholarship are recognized globally through his election to prestigious bodies such as the Academia Europaea and the European Academy of Sciences and Arts.
